Town Council Board Meets With County DPLU Leaders By Mid Hoppenrath, TC Board Member

The Town Council Board of Directors met recently with Gary Pryor, Director of the San Diego County Department of Planning and Land Use (DPLU), and Ivan Holler, Deputy Director of the DPLU, as well as Stephanie Gaines, our area planner, to discuss GP2020 issues as they relate to our valley. This type of meeting is a very rare event and a testimony to the excellent relationship the Board has built with county staff over the years of planning the Village concept.

The DPLU staff strongly support the Draft GP2020 plan, which has several hundred *fewer* homes for our area compared to the dreaded "Board Alternate" GP2020 plan. The Draft GP2020 plan also has less impact to local traffic and more protection for our open space and ridge lines. Gary and Ivan stressed that we should remain unified and consistent in our support of the Draft GP2020 plan to help defeat the Board Alternate plan.

We told them that the EFHG Town Council Board had adopted the following five positions:

- 1. Strong support for the Village plan (the Draft GP2020 plan) and strong opposition to the Board Alternative Plan.
- 2. Support for downgrading Harmony Grove and Elfin Forest Roads and Country Club Drive, and elimination of the SC1375 extension to Del Dios.
- 3. Opposition to any development of ridge lines or flood plains.
- 4. Support for Community Character Guidelines regarding rural character, septic systems, etc.
- 5. Support for equity mechanisms such as Purchase of Development Rights where applicable.

Gary mentioned that a city sewer connection can be a problem in rural areas because the county has less control over developers who petition a nearby city for sewer. He added that projects with a need for sewer as zoned, such as the Harmony Grove Village project, can have a county-regulated sewage treatment plant sized only for their requirements and thus prevent other "me-too" developers from more easily obtaining sewer for projects that would not otherwise qualify for sewer service. In the Draft GP2020 plan, only the Village would qualify for sewer service, whereas in the Board Alternative, several other projects would qualify for sewer, such as Harmony Grove Meadows and Eden Hills.

Gary, Ivan, and Stephanie understand our commitment to a rural lifestyle and the preservation of habitat. Their message was clear: we must rally to support the Draft GP2020 plan and oppose the Board Alternative plan if we are to prevent urban sprawl and maintain our rural vision for this valley.

GP2020 Circulation Plan Update How It May Affect Our Local Roads By Jacqueline Arsivaud-Benjamin and Mid Hoppenrath

This is a follow-up on the article published in the May *chaparral* detailing the Town Council request to downgrade several roads in the Elfin Forest and Harmony Grove. The county is currently considering circulation element updates as part of the GP2020 plan approval process, and now is the time to ask the county to approve our traffic goals for the keeping the area rural.

You may remember receiving one of the 400 community surveys and traffic petitions we distributed to every property owner within the boundaries of our jurisdiction, which included several traffic issues. Your feedback was pretty clear:

- Eight in ten residents strongly disagree (6 or 7 on a 7 point agreement scale) with the widening of Elfin Forest and Harmony Grove Roads from their existing 2-lane configuration to the 4 lane maximum allowed by current zoning.
- We received 93 petitions requesting the downgrade of Elfin Forest and Harmony Grove Roads from 4-lane collectors to 2-lane collectors, the vacation of the county's easement on those roads, and the removal of Country Club Drive and SC1375 from the county's map of major Circulation Elements.

Both data points have been shared with county staff at the meeting referenced in our previous article, and with the San Dieguito Planning Group. We will also be presenting the same to Supervisor Bill Horn and Supervisor Slater-Price's staff in the next few weeks.

We have previously communicated our request for the downgrading of these roads to the DPLU GP2020 team staff, as well as to the GP2020 Road Network Planning team during their presentation to the San Dieguito Planning Group on June 23, 2005. Our message has remained consistent: help us preserve the unique ecosystem and culture of our community by directing traffic to alternative routes.

We are pleased to report that the San Dieguito Planning Group has approved all of our traffic goals. We must now take our requests to the San Diego Planning Commission on July 28th and to the Board of Supervisors on August 2nd. We have had help from Eden Valley residents who are supporting our traffic goals, and from New Urban West, who has included our requests in their traffic impact analysis.

Together, we can make this happen!!

Minutes Of Elfin Forest/Harmony Grove Town Council Meeting By Steve Barker

Date: July 5, 2006

Call to Order: 7:00 PM.

Members present: Eric Anderson, Steve Barker, Jacqueline Arsivaud-Benjamin, Mid Hoppenrath and Bill Wilgenburg.

7:05: Meeting to order and introductions.

7:15: Eric Anderson introduced Debra Keeney, County of San Diego Emergency Service Coordinator. Debra gave the members an overview of the County's initiative to develop county wide "community protection plans" for the unincorporated areas of the County. The county's Office of Emergency Services, OES, is available to help the community develop a comprehensive plan to address preparation for disasters such as fire, flood and earthquake. The County offers their template and advice on how to develop a plan that would include input from the Town Council, Fire and Sheriff's Department. She suggested the community appoint a lead group to coordinate the planning effort and urged the community to visit the County's OES website at www.sdcounty.ca.gov/odp for more information. She also has available an excellent "Family Disaster Plan and Personal Survival Guide" designed to guide families through their own planning process. The Town council has some copies available. This information is also available on the OES website.

8:00: Eric introduced **Loralee Olejnik**, community relations specialist from San Diego Medical Service Enterprise, a public/ private partnership that provides 911 paramedic services to CSA 17 (a county service area, that includes Rancho Santa Fe, Solana Beach, Encinitas, Del Mar and most of the Elfin Forest. Loralee described how 911 works, who answers the call and where they are located. San Diego Medical Services operates three 24-hour and two 12-hour ambulances in CSA 17.

8:15: Jacqueline Arsivaud-Benjamin gave a road update from the recent San Dieguito Planning Group review of area roads as part of the pending GP2020 process.

8:20: Eric gave a "shout out" to the folks in Eden Valley who really have been helpful to the process to **August 2006**

keep Country Club Drive from being upgraded and designated by the County for more traffic in the GP2020 plan.

8:25: Eric reminded the community that the San Diego Planning Commission is slated to review (see Jacqueline Arsivaud-Benjamin Bridge's update in this issue of the *chaparral*) and comment on the proposed Bridges project on August 25 and that community attendance to show our displeasure with this development's impacts on our community. Call Eric Anderson for information on how you can get involved.

8:30: Eric reminded the members that there is NO AUGUST TOWN COUNCIL MEETING and the meeting adjourned.

Adjourned: 8:30 PM.

Firefighters Steeled For Duty By Patti Newton

Designed and created by local artists, Charles and Jennifer Coburn of Coburn Topiary & Garden Art, these steely characters assumed fulltime duty mounted on a boulder near the existing sign the Coburns also created for the fire department.

Fire Chief, Frank Twohy stated, "The community has invested a great deal of time, money, and sweat equity to ensure the property reflects the professionalism of the department and the values of our community. The extensive native landscaping and "fire-wise" garden belong to all of us and we're



proud to host them. The new sign remains highly visible while still blending into the landscape."

2nd Update On Bridges Unit 6 & 7 By Jacqueline Arsivaud-Benjamin

Last month we made the community aware in these pages of Bridges Unit 6 and 7, a new development to the south that would encroach into Elfin Forest and bring sewer to our valley with it. The San Diego Planning Commission was supposed to review the case on June 30 after the continuance we had requested was granted on June 2. At 5 PM the day before the hearing was supposed to take place, we learned that the matter would be pulled from the agenda and reconvened until the August 25 session of the Planning Commission. Since the last update, your Town Council Board has been working along several axes to understand the project's potential impact on our community and devise appropriate action.

Proposed Northerly Route Emergency Exit

You might recall that the Final Draft Environmental Report included a new element not previously contained in the draft, a secondary emergency route for the 26 homes proposed for the Elfin Forest side of the creek, known as Unit 7. When we reviewed that plan in more detail, it became apparent that the developer had chosen to bring the evacuating traffic from Unit 7 only to the OMWD pipeline easement which runs to Suerte Del Este, the dirt road to Rancho. The advantage to the developer of showing their emergency route stopping there is that it minimizes the need for them to mitigate the impact of disturbing sensitive native vegetation: instead of showing the full impact of taking the evacuating traffic to the nearest road, which would cut a 40 foot swath through what is currently mitigation land for close to a mile (to either Fortuna Ranch Road or Canyon de Oro), the FEIR only shows a couple hundred feet of emergency road and associated impact.

We contacted OMWD to inquire as to whether they were aware of the route described in the EIR – they were not. After our meeting OMWD submitted a letter to the Planning Commission stating that they did not authorize the Bridges to use their property in the manner described in the EIR, and proposing a better and safer egress for an emergency route (out to Fortuna Ranch Road). The pipeline easement is actually not designed to be drivable at all, as it is only a protective surface for the pipeline. The easement is very steep and narrow, making it unlikely that cars could navigate it at all. It ends on the East side on a dirt road in the middle of the chaparral, likely to be engulfed in flames in the event of a wildfire, and on the West side is not passable at all, with boulders blocking the way towards Fortuna Ranch Road in Encinitas.

We also met with our own Fire Department to go over the proposed emergency route, so they could explain to the Rancho Santa Fe Fire Department, who has jurisdiction over this project, the safety ramifications of approving the northerly route as designed. Chief Twohy has subsequently met with a LAFCO representative and will be meeting with the Lennar project manager to go over his concerns.

Impact of Sewer in Elfin Forest

As discussed in the previous article on this topic last month, this project proposes to annex to the Rancho Santa Fe Irrigation District for sewer purposes, and to bring sewer to Unit 7 in Elfin Forest via a pipe constructed within the bridge that would span the Escondido Creek. In an unrelated meeting with Gary Pryor and Ivan Holler, the top executives at the San Diego County Department of Planning of Land Use, the agency with responsibility to oversee this project, Mr. Pryor stated that "the growth inducing effects of bringing sewer to a rural community are well known". He was referring to a different project in the context of his remarks to the Board, but nonetheless it is a fact contested by no one – including those in charge of granting approval for such projects - that bringing sewer to a rural community is growth inducing. In other words it makes it considerably more likely that adjacent or nearby property owners will request annexation to the sewer district as well, to develop properties which might have been barely viable with septic, but which all of a sudden can be developed with the high density – and associated profits - that connection to sewer affords.

The Town Council's position on this issue is that sewer cannot be allowed north of the creek into Elfin Forest, regardless of what the project applicant calls the area. The purchase of the property where Unit 7 is proposed was not made at the same time as the rest of the Bridges project, but at a later time for speculative purposes, and Unit 7 is not a part of the already approved Bridges project. Simply changing the zip code to 92067 and annexing into RSF sewer does not change the reality of the topography of the area, which is a creek dividing two distinct and separate communities, those of Rancho Santa Fe and Elfin (*continued next page*)

Forest, respectively. LAFCO (the Local Agency Formation Commission, created by the Legislature in 1963 to discourage urban sprawl and encourage the orderly formation and development of local government agencies) has already ruled twice that the border between the two communities is the Escondido Creek. LAFCO named Escondido Creek as the northern boundary for Rancho Santa Fe when reviewing Rancho Santa Fe incorporation proposals in December 1986 and the community reiterated that boundary during the recent incorporation study of 2005-06.

The Town Council has communicated several times to the applicant that because Unit 7 is in Elfin Forest, we expect them to abide by our community standards, which include: no sewer, two acre minimum lot size and dark skies. We are about rural living, not suburban sprawl, even undoubtedly very high class sprawl. According to the Bridges EIR, following current zoning ordinances would allow them to build six probably spectacular estates on the land they own. Six, not twenty six as proposed. Elfin Forest has no gated communities surrounded by chain link fences topped with razor wire, as the Bridges have on their westerly border with the city of Encinitas, and would likely install on our side, nor do we plan to allow any to be built in our community.

Our Solution

We believe that there exists a solution to this seemingly intractable problem and that could be a win-win for Lennar, for the gnatcatcher, and for the surrounding communities including Elfin Forest. We are proposing that Lennar sell the 87 acres it purchased in Elfin Forest a few years ago to site Unit 7 to a land conservancy (like TECC, but it could be any conservancy of their choice), so that the land is truly preserved in perpetuity, by the title not being held by the developer.

Lennar, who recently closed its San Diego office, might look favorably on an opportunity to sell the land at a profit before real estate values in San Diego continue the downward trend recently announced, instead of getting tied up in court for years. They may also be eligible for a sizable tax write-off which could further make the deal pencil out. They would also score a big public relations win by voluntarily stepping away from destroying pristine habitat so many agencies and organizations are concerned about.

Your Town Council Board is working with TECC and others to identify potential sources of financing, and early indications are there is funding available for this type of project from a variety of sources, some local and some national.

Reneging on Biological Easement on Unit 6

As discussed in the previous article, The Bridges are also proposing to vacate a previously set aside biological easement and build 6 homes on that piece of land (Unit 6). Elfin Forest, as a community characterized by open space and rural style home sites, is very concerned about what would be a precedent-setting event if the Board of Supervisors allowed the vacation to take place. We have literally hundreds of acres in Elfin Forest as mitigation lands set aside in perpetuity to offset the negative impacts of developments or other habitat destroying projects (like pipelines).

We are concerned that once the County allows the Bridges to reverse this easement on such a large acreage for the purpose of large scale development (as opposed to allowing private homeowners to build a gazebo in their open space easement for example), this would open the door for developers everywhere – including in our community - to go back on their word and try to develop land previously set aside as open space.

For example Rancho Cielo, another neighboring project, apparently still holds the title for the over 800 acres they have open space easements on. The Bridges themselves have at least 120 acres of open space on their property, as part of Santa Fe Creek, which they also still hold title to.

Your Town Council Board's Response

To vigorously pursue the positions described above, and to understand the full array of options open to us as a community to do so, the Town Council Board has authorized joining the Escondido Creek Conservancy in hiring the law offices of Everett DeLano III, a local well-known attorney with a strong track record of winning environmental lawsuits.

We are also preparing an aggressive public relations campaign to have local media publish articles about the project's proposed impact, and the win-win

solution we are putting forward, of the land being sold to a land conservancy organization.

We will of course be meeting with our elected officials, Bill Horn, Pam Slater-Price's staff and the other members of the Board of Supervisors, who make the ultimate decision on this matter.

We wish to send the message to this developer and others watching for the outcome of this brazen land grab, that the community will not let this project go forward as is without a serious fight.

What You Can Do:

To help make sure that your elected officials understand your views, you can write either an Op-Ed piece or a letter to the Editor for the local newspapers to make your voice heard. A lot of time politicians monitor the contents and tenor of the letters to the editor as a gauge of public opinion. Please see separate article on tips to write either and contact information for the San Diego Union Tribune, the Los Angeles Times, the North County Times, and the Rancho Santa Fe Review.

The matter will be in front of the San Diego Planning Commission on August 25th at 9am at 5201 Ruffin Road, DPLU Room. Here are the various ways you can make your opinion heard, in descending order of commitment:

- You can show up and fill out a speaker form, and actually address the commissioners on your concerns about the project.

Interpretive Center at EF Reserve By Geoffrey Smith, TECC Executive Director

The Olivenhain Municipal Water District (OMWD) has obtained a grant from the State of California for an Interpretive Center to be set in the Elfin Forest Recreational Reserve (EFRR) parking lot staging area. Working with The Escondido Creek Conservancy (TECC), an exciting partnership has been established to design and build a unique facility. The purpose of the center is multi-fold, providing a much-needed nature interpretive resource for the hundreds of families, children and recreationists who come to hike the trails. The facility will also provide an important resource for OMWD rangers and TECC staff and volunteers.

TECC has enthusiastically supported this project, and has committed \$50,000 towards the construction. Recognizing the special nature of this setting, TECC is exploring a number of exciting architectural options that honor the unique natural setting in a holistic way. Discussions are under way with the architectural firm of James and Drew Hubbell (www.hubbellandhubbell.com), whose earth-friendly designs are world renowned and highly treasured. TECC Acquires HG Parcel By Geoffrey Smith, TECC Executive Director

The Escondido Creek Conservancy (TECC) added in May a new property to the Escondido Creek Preserve by securing title to a 10-acre property in San Elijo Canyon known as the 'Leriche' property. Situated on the north-west side of Harmony Grove Road opposite of the Elfin Forest Recreational Reserve, this steep and rugged parcel is now placed in open space protection under the management of TECC further preserving the sensitive watershed habitat in this area. The rich chaparral habitat is of high quality, with only a small amount of non-native invasive penetration. A small lean-to shack will need to be dismantled and removed – all in a day's work for TECC volunteers (contact the office to volunteer!) The land is designated 'Natural Upland Habitat' and falls within the pre-approved mitigation area (PAMA) under the MHCP.

TECC donors will soon be contacted for an exclusive tour of this property, which commands lofty views of San Elijo Canyon, Harmony Grove and the Elfin Forest Recreational Reserve. We've reapplied for an Assistance to Firefighters Grant (AFG) for a Wellness and Fitness. A reminder on clearance:

- Effective fuel modification zones for a defensible space around your home are 100 ft. Be careful when clearing with mowers not to hit a rock and spark a fire in the tender dry conditions.
- Limb trees up 10' to prevent remove ladder fuels.
- Clear 10' back from all driveways and roads to provide a safe escape route. Maintain at least a 13.6' vertical clearance of canopies over driveways and roadways.

With our beloved rural environment comes the danger of wildfire. Don't get caught unprepared.

Pajama Parties Poison Poll Purity By Patti Newton

Last month, after completing a poll worker seminar, I ended up involuntarily hosting a most unusual "sleepover"! Two electronic interlopers from the Registrar of Voters office with whom I'd only just become acquainted, apparently took a vote and elected to ride in the back of my Jeep so they could stay at my house for an entire week! Imagine that! You would have thought the seminar staff would have taken a couple of minutes to, at the very least, warn me of a soiree at my place or review proper etiquette for these voting machine pajama parties! I mean, what should we wear (is red, white, and blue over the top)? Do they enjoy games like, say, Hide and Seek? Pin the Tail on the Donkey (do I need to include an elephant to be fair)? And surely, these Diebold touch screen machines have become adept at playing charades by now!

Registrar of Voters, Mikel Haas, quoted in the 7/7/2006 NCT article, "Resident calls for recount in 50th District runoff," stated, "...any person who has possession of a [voting] machine must follow a strict protocol, establishing a chain of custody." Obviously Mr. Haas has never hosted a pajama party! Strict protocol and chain of custody – they sound like promising party games in need of some imaginative new rules (especially when no one is looking)!
