## Twin Oaks Extension Delayed

The *North County Times* recently reported that the opening of the long awaited link between Twin Oaks Valley and San Elijo roads has once again been delayed by construction problems until sometime in September. San Marco's City engineer Mike Edwards said it was a difficult decision to delay the opening again but plans for a partial opening in early July would have made the project even more costly. "We wanted

to wait until the project was totally complete before we opened it," said Edwards. "A partial opening, with only one lane in both directions instead of two, would have delayed the ultimate completion of the project as a whole."

A concern raised by the latest postponement is its impact on a shopping center and Albertsons grocery store planned in the San Elijo town center. Albertsons is not

contractually obligated to begin construction until the connector road is paved. "The longer the road is delayed, the longer our town center will remain a pile of dirt," said a San Elijo resident.

## *Town Council Meeting Minutes*

1) The meeting began at 7:30 pm at the Fire Station with the pledge of allegiance and introduction of members attending the meeting.

2) Treasurer's Report - Betsy Keithley. During the month of May we received \$620 from Chaparral subscriptions and advertisements and \$2750 from the Garden Festival. We had expenses of \$3000 for the Garden Festival paid to the people who opened their gardens for the festival. We outsourced the printing of the Newsletter which cost \$326.

3) Jeff Swenerton announced that there will be no meeting in July or August. It was brought up that since there is so much pressure from developers right now that we should have an August meeting. No decision was made.

Jeff reminded everyone of the July 1 Picnic pointing out that there will be a dunk tank so people should come prepared. It is never too early to start working on the floats for the parade. In New Orleans they

start one year in advance. Volunteers are needed.

4) Nominations for the Citizen of the Year were requested. In addition to Joe Alemanni and Peggy Petitmermet, Mid Hoppenrath, Frank and Pat McCollum and Karen Gardener were nominated.

5) Melanie Fallon reported that she and Jeff met with Paul Malone, the new City Manager of San Marcos to talk about our relationship with San Marcos and the University Heights proposed project. Mr. Malone would like to work with us in an open manner. At this early stage in the planning process for University Heights, the developer is proposing to build 1200 clustered units on 453 acres, leaving 50% of the 453 acres open space. The access would be onto Twin Oaks Valley Rd. They would like to be annexed into San Marcos. The land is north of the Questhaven property and abuts the southern boundary of the San Marcos City line. At

present the project land is not in the sphere of influence of San Marcos. They are in the county. Melanie has also talked with Michael Ott of LAFCO and the Town Council submitted a letter opposing the proposed annexation to San Marcos.

6) Mid Hoppenrath presented the Harmony Grove Meadows proposed project which is 216 homes built on 36 acres of a 111 acre parcel on the eastern side of Escondido Creek across Harmony Grove Road from the egg ranch. This property is currently zoned very low density (1 unit/2, 4, 8, or 20 acres) depending on the slope so that about 14 homes would be allowed. The proposed development would be very high density on very small lots on the level portion of the property. A bridge will have to be built across the Escondido Creek.

A representative of Sun Cal, the developer, was in attendance at the meeting and said they hope to submit an EIR to

the County by January of 2008. The San Dieguito Planning group will discuss the project on the 7th of June and at the same time there will be a scoping meeting at the County Planning Department on Ruffin Rd.

7) Mid reported that the city of Escondido expects to have an EIR for the Citracado Extension project ready in late August, 2007. The plan is to connect Citracado between the current end, near Harmony Grove Rd and Del Dios Highway.

Mid will keep the Town Council website updated about both of these projects.

8) There was an update presented by Nona Barker, Fire Board Chair about the County's proposed changes to County Fire Service. The Fire Department, CSA 107 was not included in phase one of the proposed reorganization. She discussed the Fire Board's thinking about what might happen next. The Fire Department has a new website [www.EFF-Fire.org](http://www.EFF-Fire.org).

9) Eric Anderson reported that Ron Pecoff,

owner of Pecoff Seed Co. across from the Fire Station, has moved away. The new owner is interested in community input about how to best use this property.

10) Jeff asked attendees at the meeting if they like the format of having extended reports on issues relevant to the community with no invited speakers and everyone agreed that it was a good idea.

11) Geoffrey Smith of The Escondido Creek Conservancy (TECC) reported that they have an architect for the design of an Interpretive Center to be built in collaboration with OMWD at the Elfin Forest Recreation Area. They still need to raise more funds.

12) Joey Randall OMWD ranger at the Recreation Area reported that the staging area will be closed Monday through Friday beginning soon so an improved bridge can be built over the creek. Parking will still be available at the overflow lot.

He also reported that a trail is under construc-

tion that will permit a continuous hike from the Recreation area through the Derbas property, purchased by TECC and now owned by the County and called "Del Dios Highlands Preserve", to the trail system of the San Dieguito River Park system at Lake Hodges.

Minutes of the previous meeting were not approved. They will appear in the June Chaparral.

## Fire Department Update

### Redesigned Website

The new web site was designed by Evelyn Alemanni and paid for through a grant from the Elfin Forest Community Foundation. The site has information for everyone. Safety, evacuation information, how to volunteer, fire prevention, stories of incidents, pictures and best of all (to me) a kids page full of fun activities for your children. The Fire Wise Garden and Native Garden brochure is available to download. Thank you Evelyn and all who submitted items for this new wonderful site.

On June 6<sup>th</sup>, 2007 Chief Twohy, Fire Board Chairwoman Nona Barker, and Directors Byron Macfarlane and Bob Kephart met with Chandra L. Waller, General Manager/Deputy Chief Administrative Officer for the Land Use and Environment Group. Ms. Waller reports to Walt Ekard Chief Administrative Officer for San Diego County. Ms. Waller was accompanied by her staff officer, Megan Jones.

The meeting was requested by Chief Twohy and Ms. Waller concurrently to discuss the Cielo Norte fund distribution.

Issues covered:

1. Cielo: Items discussed included the history of the fund agreement, grants awarded as a result of this agreement, the Cielo map extension and wording changes in the completed Environmental Impact Review. Ms. Waller stated that all money will stay within the CSA 107 and that a legal agreement will be drafted and signed.

2. New Urban West: Items discussed included the history of the development and where planning stands to date. Ms. Waller assured us that all benefit fees and most CFD monies would be coming to CSA 107. She wants to see two budgets for the new Harmony Grove station. One budget would detail the requirements for a bare bones station and the second budget would detail the requirements for a state of the art station.

3. Fire Station Building Lease: Items discussed included the history of the building and the bond. Ms. Waller will have her staff look into any bond restrictions and will research lease agreements similar to the county airport lease.

4. Benefit Fee Sunset Clause: Ms. Waller will have her staff research what happens to the benefit fees after 2015.

5. Special Districts vs. DPLU: Ms. Waller feels that the DPLU understands the needs of fire CSA's. The Special Districts are a financial mechanism. The County

wants to have a trial period of 6 months where DPLU manages the fire CSA's. By doing this the CSA's will act as more of an advisory board to the county.

6. Gary Pryor is resigning/retiring as of June 28, 2007 and no replacement has been named.

7. Last month the Fire Department had an in-house audit by the County of San Diego. The Fire Department will be getting a copy of this audit in the next three weeks.

All in all this meeting was very positive. Chief Twohy and the Fire Advisory Directors are still working very hard to make any transition as smooth as possible.

## *What's Happening at the Fire Department—July 2007*

We are thrilled to announce final approval notification of the San Diego County EMS Trust Fund Grant. This award of \$26,000 will allow us to provide a Washer/Extractor and Dryer for washing Firefighter structure turnouts and brush gear. Having tried for this important grant several times, we have finally been successful. The ability for the Firefighters to be able to easily keep their personal protective equipment free of contaminants is an important health and safety issue for us. Previously, Fire-fights had to take their equipment out of service and transport it to another fire station some distance away for cleaning. This grant will help us to keep our Firefighters clean, healthy, and in service here to serve you.

Crews attended the County Wildland Readiness Drill in Barona recently on Engine 2811. The drill covered such important topics as communications, structure triage and structure pro-

tection, helicopter operations, fire shelter deployment, mobile pumping and a progressive hose lay, and a review of the Firefighter fatalities on the Espiranza Incident. This invaluable training will help us prepare for what's looking like a busy fire season.

You may also see the Firefighters out doing some hiking. Mike Sampson and the Health and Fitness Committee are really pushing us to get out and get physical. He's got them going out frequently, with the hikes getting longer each time. Sometimes you might even see them wearing forty pound wildland hose packs like the ones they have to carry up the hill on a progressive hose lay. These young guys are truly amazing, and work so hard at staying physically fit to meet the demands of the job.

Here's a big "Get Well Soon" wish to our Bookkeeper Vickie Kleen, recovering from recent surgery. Miss you Vickie, and can't wait till you come back. It's

just not the same without you around.

Hope you all are able to come to the 4<sup>th</sup> of July Parade and Picnic on Sunday July 1<sup>st</sup>. It will be a great day of fun and festivities, and a time to spend time with family and friends. The Town Council has worked so hard to make it the best ever. Please join us.

A reminder that conditions are ripe for fire. Fuel moistures are incredibly low early in the season. ## New EDCO Recycling Program

Starting in July 2007 EDCO is introducing a new commingled recycling program.

EDCO will be distributing a 65 gallon cart to each residence. The cart will even have wheels! All your recyclables can be put into one vessel.

Commingled recycling helps reduce scavenging as redemption-value cans and bottles can be concealed under other recyclables. Commingled recycling also makes it that much easier for the consumer to recycle because there is no sorting necessary.

Recycling helps divert materials from area landfills which further helps the county reach its mandated recycling goals.

## Recycling Guidelines

The following are guidelines of materials can be recycled. All of these materials can be put into the new blue EDCO cart.

### Glass Bottles & Jars

Recycle all food and beverage containers—clear and colored glass. Please rinse. No need to remove labels though.

### Cardboard

Flatten or cut boxes to a maximum size of 3 ft. x 3 ft.

### Newspapers

Recycle your newspaper and everything that is delivered with it—including inserts, coupons, etc.

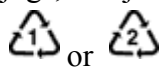
### Cans

Recycle aluminum cans and steel cans—including clean & dry

paint cans, and empty aerosol cans. Also recycle aluminum foil.

### Plastic Containers

Recycle plastic bottles, jugs, and jars marked



, and all beverage containers labeled "CA Redemption Value" or "CA Cash Refund" including:

**Food & Beverage Containers** — Milk, soda, water, salad dressings, cooking oil, etc.

**Jars & Canisters** — Peanut butter jars, mayonnaise jars, aspirin bottles and 35mm film canisters.

**Cleaning Products & Detergents** — Bleach, detergent, soap, shampoo, drain cleaners, etc. (Containers must be empty.)

**Automotive & Yard Care Products** — EMPTY motor oil, antifreeze, plant food and herbicide containers.

### Mixed Paper

Recycle virtually all clean and dry paper including: writing paper (all colors), computer paper, Xerox paper, "no carbon required" (NCR) forms, catalogs, brochures, magazines, junk mail, phone books, post-it type notes, and shredded paper. EDCO accepts them all, PLUS if those items have staples, window envelopes, or even those little metal clasps on legal envelopes, they're OK, too!

You can also recycle cereal boxes and other clean food packaging, including cake boxes, flour bags, frozen dinner boxes, paper egg cartons, and soda/beer 12-pack carrying boxes. Also recycle paper grocery bags, gift boxes, shoe boxes, paper gift wrap, calendars, and core tubes from paper towels, etc.



## Got Horticulture Headaches?

Aspirin is a well known cure-all for people, but is it good for plants? After reading about the idea that spraying plants with 2 aspirins dissolved in two gallons of water makes them grow like crazy, I decided not just to try it, but to do some research on other applications for aspirin in the garden. I love my plants to grow huge, and if I can make that happen with something that costs about \$3 for 1000 pills at Costco, you've got my attention.

It turns out that salicylic acid, the main ingredient in aspirin, is commonly used to ward off plant diseases. According to Martha McBurney, a Rhode Island master gardener, giving plants aspirin helps boost their immune systems, preventing some common plant ailments and resulting in "plants that grow as if on steroids."

John Paterson, a researcher from Scotland says that if a plant's infected by bacteria or a virus, it often synthesizes salicylic acid which acts as a chemical signal. It then interacts with genes within the plant to produce defense proteins.

Here are some of the

uses for aspirin in the garden.

### Aspirin Spray

Dissolve two aspirins in a tablespoon of vinegar. Dilute with 2 gallons of water. You can add a little Miracle Gro, fish emulsion, or other plant food to the mix. Spray this mixture on anything and everything in the garden, even houseplants. Repeat every three weeks. The theory is that this makes plants, particularly roses, less susceptible to powdery mildew, insect infestations, and other diseases because the aspirin enhances and reinforces the plants' defense mechanisms. However, some scientists think that the aspirin mixture does not, in and of itself, activate any defense mechanisms in the plant, that spraying the solution may result in foliage damage through burns, and that the whole idea smacks more of home quackery than a home remedy. So, lucky for you, I tested it in my garden, and some roses put on lots of new growth, while one called First Prize started to wilt. I sprayed the solution on my raspberry plants... one turned brown, the others put out new shoots, abundant flow-

ers, and the biggest raspberries we've ever had. Go figure.

### Straight Aspirin

A docent at Quail Botanical Gardens says she crushes 3 aspirins and sprinkles them around each of her roses, then waters, and repeats the treatment every two weeks. After hearing that, I ran to Costco, bought a 1000 pill bottle of aspirin, put it in the blender to crush them, then sprinkled it on the roses. Since most of my roses are in cages to keep the bunnies from having a thorny dinner, I wasn't too concerned about the dogs getting a nose full of aspirin. However, if pets have access to your garden areas, it may be better to mix the crushed aspirin with water and pour a little on the soil around your plants instead.

### Germinating Seeds

Several reports on the web insist that watering with aspirin water helps seed germination and speeds up propagation from cuttings. Just spray the soil (or in the case of cuttings, the leaves and stems) with the aspirin spray recipe listed above.

## Preventing Summer Emergencies



Summer in San Diego always comes with a special set of challenges for 9-1-1 emergency responders.

San Diego Medical Services Enterprise (SDMSE), your 9-1-1 paramedic provider, would like to tell you about some special programs we are running throughout the season, as well as share some tips on how you and your family can avoid common summertime medical emergencies and get safely through Labor Day.

Throughout the month of August, all SDMSE ambulances and city fire vehicles are outfitted with ribbons or posters for "Purple Ribbon Month," a campaign to remind people never to leave children in or around vehicles unattended, especially during the hot summer months. Teaming up with non-profit 4 R Kids Sake, SDMSE's goal is to raise awareness of how small children are more susceptible to emergencies such as hyperthermia when left in a vehicle, even if only for a few minutes.



Remember to keep car doors and trunks locked, even when parked in a driveway. Even if you do not have children in your household, neighborhood kids can find their way into your vehicle and become trapped.

If you have children, teach them not to play in or around vehicles, and if a friend is playing in a vehicle, to tell an adult. Show them how to unlock car doors, and make sure your vehicle has a trunk release. If your child is missing, look immediately in your vehicle and neighborhood vehicles.

Along with campaigns such as Purple Ribbon Month, the city's EMS system utilizes various innovative means to deliver emergency care to San Diegans throughout the summer.

For example, at the beaches during the Fourth of July and at large events, we utilize bicycle paramedic teams. This program has been highly successful in reaching patients quickly in crowded, difficult-to-access places.

Below are some more tips for a safe summer.

Though they may seem obvious, they are still some of the more common reasons why emergency responders are called.

-Many emergencies we respond to are alcohol-related. Drink responsibly, don't ever drink and drive.

-Remember to keep well hydrated by drinking enough water, especially while exercising or during long days at the beach.

-Proper sun protection, including sun block, hats, and protective clothing is essential.

-Use fire pits and properly dispose of hot coals after a bonfire. Do NOT bury them in the sand where they can be stepped on by unsuspecting victims.

-Make sure that elderly and infirm individuals have proper access to fans or air conditioning. SDMSE is a public-private partnership between the San Diego Fire-Rescue Department and Rural/Metro Ambulance. We provide all 9-1-1 emergency medical transportation in the cities of San Diego, Del Mar, Encinitas, Solana

Beach and Rancho Santa Fe.

SDMSE also provides ambulance service for large events such as Chargers and Padres games, the Rock and Roll Marathon, the San Diego County Fair, and we also provide non-

emergency medical transportation.

SDMSE also spends several hundreds of hours per year in community outreach activities, including speaking to community groups, participating in health and information fairs, street festivals, and giving

presentations to seniors.

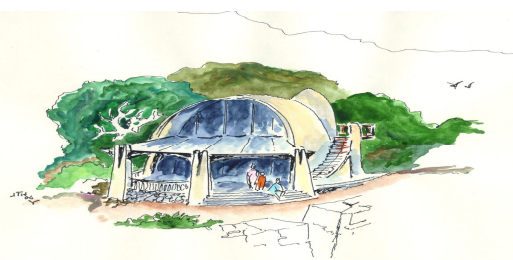


## Design Update for the New Recreational Reserve Interpretive Center

On May 23, 2007 the Olivenhain Municipal Water District (OMWD) Board of Directors awarded an agreement with the renowned architectural firm Hubbell and Hubbell to design the new Elfin Forest Recreational Reserve (Reserve) Interpretive Center to be located at the Reserve's trailhead located on Harmony Grove Road. The decision to award the agreement to Hubbell and Hubbell came from recommendations made by the OMWD staff and project partner, The Escondido Creek Conservancy (TECC). The Hubbells were selected from a highly qualified field of five design firms, each of whom of-

fered a significant list of accomplishments for consideration.

The father and son team of James and Drew Hubbell, of Wynola and San Diego, will produce three conceptual designs, of which one will be selected in July to be built. Construction is expected to commence in January 2008, with occupancy scheduled for mid-2009. The District received a grant in the amount of \$68,500 from the California State Parks Land and Water Conservation Fund for this project. The grant requires a 50/50 match and TECC has partnered up with the District to provide that match. The purpose of this project is to build an indoor interpretive center



that will allow for the park rangers to be more accessible to park users and to create a complete trailhead. The park rangers currently have an outdoor interpretive center and due to the remote location, the amenities located there have often been subject to vandalism, theft and destruction. The interpretive center will offer visitors the opportunity to enhance their outdoor recreational experience with a better

understanding of San Diego's native habitat and why it is worth setting aside to protect. The Interpretive Center will be built above the flood plain to prevent flood damage from Escondido Creek. Nearly \$300,000 in total donations has been raised to date, towards a capital campaign goal of \$600,000.

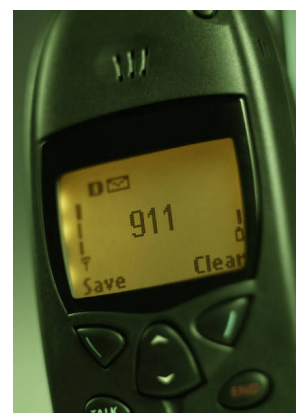
