From The (Weedy) Field By Eric Anderson

The October town council meeting is going to be action packed with elves, issues, food, door prizes and special guests! **You** absolutely, positively, must be there or your hard working board members will get demoralized. We can't have that can we? The Board has been working hard and now has the frame work for a strategic plan. I am so impressed with our board members. I can't tell you how very lucky we are to have them working on behalf of our community.

In between we have been active responding to the New Urban West EIR and the Bridges 6 & 7 project. Jacqueline along with The Escondido Creek Conservancy (TECC) and Endangered Habitat League has done a miraculous job slowing down the Bridges, which had been considered a "slam dunk" project. Now it is a long way from being done, but the developer's forward progress has come to a halt. The developer is meeting with us to discuss possible sale of Bridges 7 for open space as it is an important core gnatcatcher area. The town council is cooperating with TECC in hiring Everett Delano, an excellent CEQA attorney, to represent us on the Bridges project.

The NUW EIR was a very complete and extensive document. Besides the large EIR there were thousands of pages of technical appendices that covered everything from agriculture to traffic impacts of the project. The Village Subcommittee did an excellent job of addressing concerns in the

Update On Bridges Unit 6 And 7: Major Victory By Jacqueline Arsivaud-Benjamin

Thanks in part to all of you who made your voices heard by contacting the San Diego Planning Commission, the project has now hit a *major* snag. After years of supporting the project, the San Diego County Department of Planning and Land Use <u>recommended denial</u> to the San Diego Planning Commission. As a result the Bridges asked for a 120 day continuance until December 15, 2006. This is a major setback for the developer and while it is far from being over yet, we believe the grass-roots organizing of the community played no small role in this outcome.

Since our last update in these pages, we published the press release found elsewhere in this newsletter, which gives details on reason for denial. As a result we had three reporters at the hearing, from the Union Tribune, the Rancho Santa Fe Review and the Rancho Santa Fe News.

An August 30 San Diego Union Tribune article (www.signonsandiego.com/uniontrib/20060830/new <u>s 1mc30elfin.html</u>) resulted in additional coverage on KPBS radio morning news, Fox TV evening news, and a full interview on Channel 10 News on August 31, with a crew sent to Elfin Forest to produce a piece on the controversy. Finally the Rancho Santa Fe News had a front page article on September 1, titled "Bridges progress stalled for bird's sake".

As a result of all this pressure, Lennar has agreed to sit down with representatives of your Town Council Board, The Escondido Creek Conservancy and the Nature Conservancy, to start negotiations on purchasing the 82 acres of pristine coastal sage scrub which would have been Unit 7. Stay tuned...

Great news! AT&T thinks they will be able to get all of us in the Elfin Forest area high speed Internet (either DSL or FTTN – fiber to the neighborhood) very soon. They are in the process of finalizing easement rights to a small piece of property along Elfin Forest Road where they will need to put their equipment to upgrade service in our area. Once this is completed, they will notify us on the progress.

They said it would not happen in the next couple of weeks, more like within the next few months since there is still quite a bit of work to do. We now have over 80 families on the "DSL wish list". I'll keep you posted on progress and hopefully will soon be able to provide you with a contact name and phone number once they are ready to install.

2005 Survey Results (Finally) By Karen Gardner

A long time in coming, the 2005 EF/HG survey results are complete. A comprehensive report and tabulation will be available on the Elfin Forest Town Council web-site soon. An Elf Alert will be sent out notifying the community when the new results are posted and a link to the results will be provided.

In the mean time ... just a few interesting statistics.

- Ninety-two percent of residents feel that the rural atmosphere is important in their decision to live in the valley (extremely important or very important).
- A quarter of the community residents have been here for five years or less and a quarter of the community has been here for over 20 years.
- Fifty-two percent of residents stated that the ability to keep horses and large animals is extremely important or somewhat important in their decision to live in the community.
- Traffic was the most frequently cited ad-hoc response given when residents were queried as to what the most pressing issues were facing the community.
- Approximately eighty percent of residents do not want to see Harmony Grove Road or Elfin Forest Road widened.
- The majority of community residents (59%) do not support the development of a community park and playground in the community.
- An even larger proportion of residents (81%) do not support the development of a sports park in the community.
- Sixty-eight percent of the community state that they read the Chaparral every month.
- According to residents, over eighty percent feel that residential zoning should remain at 1 dwelling unit per 2 acres or more (1du/2ac).
- Seventy-four percent of community residents want to preserve the agricultural areas and ninety percent feel that commercial development should be restricted.

What A Loss! By Evelyn Alemanni

Losing agricultural resources is one way that we lose our rural environmental. The following excerpt is from section 4 of the Harmony Grove Village EIR. You can access the entire EIR online at: <u>www.sdcounty.ca.gov/dplu/docs/PR/9-18-</u> <u>06/0408011.html</u>.

The proposed project would result in the loss of approximately 80 acres of avocados and 9 acres of citrus orchards. Closure of the two on-site egg ranch facilities would result in a combined annual production loss of approximately 9.5 million dozen eggs; nearly 10% of total County production in 2002.

Closure of the on-site dairy facility would result in an annual milk production loss of approximately 94,170 hundredweight, a 7.8% decline in countywide milk production for 2002.

There is also a loss of up to 1.05 acres of oat hay production.

Get Ready For The 2007 Elfin Forest Garden Festival By Karen Gardner

Your town council has started in earnest organizing the 2007 Elfin Forest Garden Festival which will be held on Saturday April 21, 2007, a day before Earth Day. This event, started in 2003 by Evelyn Alemanni, is our community's largest fundraiser and has positioned Elfin Forest as a community with exceptional landscapes. In the past, the festival has drawn visitors from five states and three countries, and nearly every town in the county.

As development seems to be encroaching on all sides of our beautiful valley, it has been necessary to hire outside experts to thwart the advance of the tract-mansion. As an example, just recently, the town council, in conjunction with The Escondido Creek Conservancy (TECC), staved off imminent expansion of the Bridges (and sewer!) into the Elfin Forest valley. The success of this endeavor was due, in part, to funds provided by the town council to hire experts and an attorney. (Thank you Jacqueline Arsivaud-Benjamin!!!!) It is necessary now more than ever for our community to band together and make this fundraising event successful. In addition to supporting the town council, proceeds from the event will go to TECC, the Firewise demonstration garden, fire department, and other Elfin Forest organizations designated by the garden hosts.



California Invasives By Evelyn Alemanni

Keeping our native areas native is increasingly challenging as seeds from "exotics" (non-natives) encroach our undisturbed areas. You can help preserve our native habitat by not planting invasives. The California Invasive Plant Council (www.calipc.org) has prepared a complete list of invasives, along with photos for easy reference. The problem plants listed on their site can escape from gardens in the Southern California region and invade wildlands. Because of their aggressive growth, these plants degrade native habitat and some increase flood and fire risk.

The web site (<u>www.cal-ipc.org/landscaping/dpp/</u> <u>invphotos.php?groupID=60®ion=state&type=</u> <u>trees</u>) lists desirable landscaping plants that serve as good alternatives to the invasive plants. There are some surprises on the site. For example, the California Invasive Plant Council considers the California pepper tree (*Schinus molle*) invasive.

October Garden Projects By Evelyn Alemanni

As the ten year anniversary of the Harmony Grove Fire approaches, our gardening priorities increasingly relate to fire safety. Of course, you should have been taking care of this all summer, but if not, what are you waiting for? I recall ten years ago, sounds of fire engines and flames crackling with overtones of weedwackers and chainsaws as people made a last effort to clear flammable brush to protect their homes from the rapidly advancing fire.

A firestorm doesn't give you much time to clear the garden, let alone evacuate with your most precious possessions, so don't wait, do it now. Check your community guide for a complete listing of fire prevention and preparedness tips. If you don't have a community guide, stop by any town council meeting and purchase one. They're only \$20.

Easier garden projects for October include planting our fall vegetables – lettuce, broccoli, cabbages, brussel sprouts, winter squash and onions. Try planting some of the new "cool season" tomatoes that have been recently introduced. These heirloom tomatoes come from places like Siberia, the Czech Republic and Poland where they have been grown with very limited heat. Plant them now! Imagine no more wooden tomato look-alikes from the grocery store for Thanksgiving dinner!



In the flower garden, October is the time to plant ranunculus, anemones and all the lovely spring annuals – stock, larkspur, snapdragons, calendula, forget-me-nots are just some. Plants that are

started in October have a good 4 to 6 weeks of warm weather to get established and by spring will reward you with lots of flowers. As soon as we get the first fall rain, you can start sowing wildflower seeds.

If you grow roses, there are two schools of thought regarding their fall care: one is that fertilizer should be stopped now so that the plants can go gradually dormant. The other is that roses can be lightly pruned in October, fertilized and watered well, so that roses will bloom for Christmas. Take your pick, there's no wrong answer.

Those Popular Dark Skies By Evelyn Alemanni

Every two months or so, one elf or another calls me about a neighbor who leaves bright lights on at night. Reluctant to report their offending neighbor to the authorities, they then ask if we would put an article in the newsletter about the dark sky ordinance. We have run the article many times, and the issue is discussed in depth in the community guide. (Don't have one? Get one! Ask any town council member.)

Briefly, the dark sky ordinance is intended to prevent light pollution from interfering with the work done at local observatories. The county has a dark sky ordinance that says: "All outside illumination of any building and/or surrounding landscape, public or private, for esthetic or decorative purposes is prohibited between 11:00pm and sunrise."

We all want to enjoy the starry nights, and the astronomers want to do their work, so please be a good neighbor and turn off your outdoor lights. Not a lot of common denominators are noted, and it is happening in all types of fuel to some highly experienced firefighters. Please, stay alert, and if asked to evacuate...do so immediately. Report any suspicious activity right away. Better safe than sorry. And please join us for the Harmony Fire/Del Dios Fire Commemoration October 7, 10, 12, and 14. Now, ten years later, we will join together "*To Remind, Educate and Remember*" these tragic events. For those of you who where here in 1996, come help us to share our experiences.

For the some 50% of our communities who have never experienced wildfire in a rural wildland interface environment, come and hear first hand the horror of a firestorm in your own community. Come and educate yourself on how to help prevent it, how to help ensure the safety of your loved ones, and how to give your home a fighting chance of survival.

County Staff recommends rejecting Bridges application

After conducting an in-depth scientific study and consulting an expert ornithologist, the County Department of Planning and Land Use (DPLU) is recommending denial of the pending Bridges at Rancho Santa Fe application to expand across the Escondido Creek, and to build on a previously set aside biological open space easement. "This reflects the extraordinary adverse impacts of this project," stated Everett Delano, an Escondido attorney retained by the Elfin Forest Harmony Grove Town Council and The Escondido Creek Conservancy to address the Project's impacts. "County staff correctly recognizes the special value of this sensitive habitat," Delano explained.

The staff report, just released on the DPLU website, recommends denying all aspects of the application (two Specific Plan Amendments, two Tentative Maps, two Major Use Permits, and one Administrative Permit). The key reason for the change in recommendation is that the Bridges at Rancho Santa Fe would be sprawling into pristine coastal sage scrub habitat which is critical to the long term survival of the California gnatcatcher, an endangered species, and to the success of the entire North County Multiple Species Conservation Plan, or MSCP-N. Future development and public projects, such as road improvements, depend upon MSCP-N for permitting. The DPLU report states "…the Department believes that development of either Alternative for Unit 7 may lead to the extinction of the CG [California gnatcatcher] Core Area population".

This is just the latest set back for The Bridges at Rancho Santa Fe, a luxury golf community built by Lennar and situated on the south side of the Escondido Creek, which has met with escalating community opposition to the project. Conservation groups involved in the MSCP-N earlier determined that trying to minimize the project footprint would not work, and suggested that Lennar consider selling the 87 acres to a land conservancy.

The matter will be in front of the San Diego Planning Commission on August 25th at 9am, where community representatives are expected, and from there will be decided by the Board of Supervisors.
