Completion of the survey will allow the Town Council to know how **YOU** want the community to develop over the next twenty years. Your **confidential input** will enable the Town Council to more accurately represent your interests in the many issues facing the community, as we confront prospective developers and others attempting to change some of our community's characteristics. The survey data will be compiled and presented to the County so that your collective opinions are considered as the County updates its general plan and its long-range community plan, GP2020, which is also in preparation. Minutes Of Elfin Forest/Harmony Grove Town Council Meeting

DATE: May 1, 2002

MEMBERS PRESENT: Bill Telesco, Evelyn Alemanni, Patti Newton, Linda Hamilton, Mid Hoppenrath, Nancy Reed, Eric Anderson, Janet McGurk

CALL TO ORDER: 7:35 p.m.

ITEM #1: Alex Newton, field rep and **Rebecca Cole**, public relations, of the Olivenhain Municipal Water District updated residents on the dam project and urged them to call with any questions and concerns. As is the custom of the County Water Authority, dams are normally named to reflect the geographic area they occupy; a permanent name change will be considered on May 23rd. Residents were asked which they preferred of six potential names, i.e., Harmony Grove, Harmony, Box Canyon, Del Dios, Elfin Forest, Olivenhain. Residents overwhelmingly approved Elfin Forest.

ITEM #2: John Rollin, and **Julia Quinn**, of the S.D. County Department of Public Works (DPW), discussed issues regarding the final closure of the San Marcos Landfill. The EIR comments from concerned citizens are due by May 20th. The town council has drafted a comment letter and placed it on the web site for review before sending it. The EIR will be certified June 19th. The DPW anticipates commencement of construction (court mandated timeframe) in August 2003. The DPW will need to import approximately 430,000 cubic yards of soil, necessitating 30,000 truck trips over about seven months. That equates to 400 one-way truck trips per day between the hours of 7 a.m. and 4 p.m. A final route has not been identified since a supplier for the cover material has not yet been selected. The material required is of a very specific composition as per the Title 7 and court-mandated requirements. It was suggested that the DPW wait on the closure until the local road improvements are completed; the DPW would have to get permission from the Regional Water Quality Control Board (RWQCB) and the Integrated Waste Management Board (IWMB). Residents asked for consideration of extra CHP and flagmen, a change in the hours of operation to avoid peak traffic snarls, and mitigation for any blasting (if it occurs). The buffer zone will remain unchanged until the City of San Marcos is satisfied with the closure. The County of San Diego can rescind the open space easement if it desires. Residents suggested it be dedicated as open space in

perpetuity. Rollin suggested these comments be included in the EIR comments.

ITEM #3: Curt Noland and **Jeff O'Conner**, San Elijo Hills (SEH), updated residents on SEH. There are 135,000 square feet of commercial space in the town center that will become available the middle of next year. Update on status of permits relating to roads. They anticipate completion of improvements to San Elijo Road by the time of the final closure of the landfill. Rancho Santa Fe Road from San Elijo Road to La Costa Avenue has been cleared and staked. Supposed to be an 18-month timeframe but work seems to be stopped for unknown reasons. The funding is in place for this and the improvements scheduled for San Elijo Road to Melrose. San Marcos has the remainder out for bid. San Elijo Road east through the SEH project (approx. 2.5 miles) has been designed and has gone through plan check. Rights of way have been acquired (with one exception) and all permits are ready, however, SEH will wait for University Commons (presumably by the end of the year). Tenants under consideration for the grocery in the town center are commensurate with Boney's, Henry's, although one of the "Big Three" is still a possibility. Residents registered their disgust with the orange street lights. Curt agreed to consider alternatives and get back to the community. The City of San Marcos is likely to vote on the proposed ridgeline golf course this August. There are currently 421 occupied homes in SEH. Grading and blasting will continue for another four to six weeks.

ITEM #4: Open Forum. Janet McGurk: The fourth of July Parade/picnic will be on June 30th. It will be a potluck this year. We still need volunteers and donations for the raffle and silent auction. **Ari Franken** announced the formation of a new Yoga class to begin May 22nd. It is designed for all levels and will begin at 6:30 p.m. at the firehouse. **Evelyn Alemanni:** There is an opening for a new board member on the town council. Interested parties can contact any board member for information. **Patti Newton:** One of the new mailbox kiosks has been broken into. Suggested people refrain from mailing anything until the morning before the carrier arrives.

The San Marcos Growth Management and Neighborhood Protection Act

The San Marcos Chamber of Citizens needs your help and support in collecting signatures for "The San Marcos Growth Management and Neighborhood Protection Act". To qualify this initiative for the November 5th election we need 2,500 Registered Voters from the City of San Marcos to sign it before June 14th. This Initiative allows the citizens of San Marcos the "RIGHT TO VOTE " on the amount of growth and development over and above what the General Plan now allows.

San Marcos has a General Plan that will permit up to 98,000 people and the commercial and industrial development to serve them. Our current population is 54,000. This initiative says if you want to increase San Marcos's holding capacity beyond this level, then the people of San Marcos must be allowed to vote on the specific proposal.

Currently all it takes is a simple majority vote of our city council members, who might be influenced by special interest groups, to get approval for higher density and intensity of use changes to our General Plan.

This initiative includes protection for sphere of influence proposals, which San Marcos is always so eager to annex and approve higher density zoning changes to. Currently there is such a project threatening to induce more urban sprawl into some sensitive wildlife corridors, and create more destruction of wildlife habitat north of Palomar College.

The "Highlands" project is tentatively scheduled for presentation to the Planning Commission on June 3rd. This high-density housing project is being proposed on land that is presently zoned one dwelling per 2 or 4 acres. Its plans will put 230 homes on a portion of a 225-acre site that is 60% percent in the unincorporated area of San Diego County. The extension of Las Posas Road across Hedionda Creek required for this project is just the beginning. Once Las Posas crosses the creek it will be possible for the rest of this valley to be developed in a similar manner to the Santa Fe Hills, high-density project that adjoins it. The city is pushing for this project with intent to extend Las Posas Road through to the rural area of Buena Creek Road in Vista.

The "Friends of Hedionda Creek" needs our help alerting the Santa Fe Hills community of the upcoming meeting to encourage their presence and voice their concerns at the Planning Commission meeting. Therefore, a joint effort of distributing information about this high-density proposal and gathering signatures for our petition will be held.

We will be going door to door so we need a lot of help! Please join us on Saturday, June 1st from 10:00 A.M. to 12:30 for our "FOCUS on SANTA FE HILLS" joint effort. If you are unable to help with this event, we still urgently need your help collecting signatures on any day before June 14th. Congratulations to Community Foundation Grant Recipients

The board of directors of the Elfin Forest Community Foundation met on Thursday evening, April 25, 2002 to evaluate the grant proposals that were submitted by the March 15, 2002 deadline. All proposals were funded. The projects are (in no particular order):

- 1) Elfin Forest Trails Committee - \$2,600 for fencing and landscaping associated with a trail along Elfin Forest Lane.
- 2) Elfin Forest Landscape Foundation - \$8,800 for continuation of the project to landscape and put trail fencing along Elfin Forest Road.
- 3) Elfin Forest Landscape Foundation - \$1,000 to cover the cost of rebuilding the engine of the landscape mini-truck used in the Elfin Forest Rd project.
- 4) Elfin Forest Landscape Foundation - \$650 to cover the cost of removing 2 eucalyptus trees from the trails-right of way on the Brown's property.
- 5) Elfin Forest/Harmony Grove Fire Department - \$2,781.15 to cover the cost of 10 Icon programmable hand held VHF portable radios.
- 6) Elfin Forest/Harmony Grove Town Council - \$2,500 to cover the up-front costs of the annual 4th of July picnic.

Congratulations to all the recipients and the community thanks you for your involvement and commitment to helping maintain the rural environment of Elfin Forest and Harmony Grove.

WHOA!!!!!!

As urban sprawl continues to consume North County, horse properties are becoming more and more scarce and soon will be few and far between. That's great for Elfin Forest property values. Or is it? Recently, some realtors have been promoting Elfin Forest as a great place to establish public horse facilities in our private rural community. Do you want boarding stables on a grand scale operating seven days a week popping up here and there or possibly even next door? I don't!

County zoning laws specify that our horse properties be for personal horse keeping only. Check out what the County Department of Planning and Land Use has to say about horse keeping on the Internet starting at www.co.san-diego.ca.us. In the Animal Schedule of the Zoning Ordinance Summary our properties have an Animal Regulation Designation of "V." This designation requires that a Major Use Permit (MUP) be obtained for a V designated property to be used as a "Public Stable" or "Boarding and Breeding Stable." There are many requirements to obtain a MUP including consent of a majority of the immediate neighbors. The County will enforce zoning violations and the fines are harsh.

Residents of San Elijo Hills might think this is a great place to board their horses and use our trails. We don't share their enthusiasm nor do we appreciate them using Elfin Forest to promote their community. Remember folks; only a small portion of their community is currently built.

We have to fight hard to save what we have otherwise we don't deserve to keep it. Zoning enforcement starts with you. It's your choice. You have access to the information. Read and share it. Let's all continue to keep protecting the future of this rare and special place.

Rancho Santa Fe School District's Search for New School Sites

Due to questions regarding the survey sent out by the Rancho Santa Fe (RSF) School District (the District), I wrote this article to help everyone understand why, from this writer's point of view, there is an immediate need to build a new school. The current school was designed for 500-600 students and now has a student population of approximately 775. There are 14 "portables" (temporary trailer classrooms) on the school playground area to house the overflow of students. Approximately 70 students from Elfin Forest attend the RSF Elementary School. A demographic study ordered by the District predicts that this will increase to around 137 by 2008.

For over two years the District has been searching for a new school site within its boundaries. Out of an original list of nineteen sites, they are down to two: the Quantum and Salm sites. Other properties were deemed unacceptable for a variety of reasons: inaccessibility due to narrow and/or private roads, too steep, locations near plant nurseries where hazardous pesticides were or are being used, too close to an aqueduct (a water line under very high pressure), etc. There've been multiple public meetings of the RSF District Board (the Board) discussing this issue this year alone. If you are interested in attending Board meetings check the *chaparral* for dates and times or call the school at 858-756-1141. The office staff is there during the summer.

The Quantum site on Del Dios Highway at the junction of El Camino del Norte is approximately 36.6 acres (24 net usable acres) of raw land. It is large enough to accommodate a school site and possibly community playing fields and another community or neighbor joint use. The Salm site is north of Del Dios Highway east and not far from the Quantum site. It is narrower than the Quantum site and is just west of the "Summit" Development. There are 27.5 acres (approx. 20 net usable) of raw land. The Quantum site is a property inside the "covenant" of RSF and the Salm site is not. The Quantum site is currently for sale and the Salm is not.

The Board will decide what type of school will be built on any site. It is projected that at build out the District will need about three elementary schools and one middle school to accommodate all of the students

given the current District boundaries. The Board also decides whether the elementary schools will be K-4, K-5 or K-6, as well as what grades will be in the middle school: 5-8, 6-8 or 7-8. The site committee, set up by Superintendent Dr. Daniel Vinson and representing people from all over the district, voted to recommend that the Board: site a middle school at the Quantum site and continue as additional information becomes available, explore the Salm site, and keep the current school in RSF as an elementary school (K-4, K-5 or K-6). The Board may accept, modify, or reject these recommendations and no decision will be made until after public meetings.

To my knowledge, there are only a few sites in Elfin Forest suitable for a school. There have yet been no public presentations to the Board regarding possible sites in Elfin Forest. But because the school would require a minimum of 8-10 acres, the logical sites that the school could purchase, in my opinion, would be either from the Quail Ridge development somewhere near Fortuna del Norte (but far enough away from the aqueduct) or by Elfin Oaks/Circa de Media, or they could purchase property adjacent to Colina Encantada (open land in the process of a lot split by Michael Garrison). All of these properties are along Elfin Forest Road. Due to the fact that most of the other roads in Elfin Forest are narrow, curvy, and privately maintained, Elfin Forest Road would appear to have the least impact with the best accessibility for the majority of residents.

Having the District purchase property in Elfin Forest now is, again in my opinion, very important. It allows the District to buy at today's prices and hold the land until needed (if needed) putting future property owners and developers on notice that a school could be built on that particular site in the future. Not buying now guarantees not having a school here at all because it is unlikely a suitable (8-10 acres) site will be available.

A school will not be built in Elfin Forest until there are enough Elfin Forest students to support it and/or the other schools are full (or near full). It will probably be an elementary-only school with its actual grade configuration determined by the Board. It would remain in the RSF District with the same high quality of education and standards as other schools in the District. Children could walk or ride bikes to school and their parents would benefit from the shorter commute. **(Continued Next Page)**

If a school were not built here, eventually the other schools in the district would become over-crowded. I believe smaller schools and smaller classrooms equate to better learning and higher test scores by students. Middle school students from Elfin Forest would still attend school in the RSF area, wherever the District decides to place the middle school.

I have talked with Dr. Vinson on many occasions and can tell you he is a man who thinks towards the future. He is very intelligent and very fair. He, like the Board, only wants the best for ALL of the children, regardless of whether those children live in or out of the covenant. The teachers in the school and all of the parents I have spoken with think he is wonderful. Dr. Vinson joined the District this school year after the retirement of the prior superintendent, Dr. Rowe, last year. He has come into this school with an incredibly difficult task to accomplish...to site a new school as soon as possible and deserves our support. We are hoping to have him out to our Town Council meeting in August, thanks to Evelyn Alemanni, to talk to us about the District's plans to site and/or build new schools.

Thank to Curt Noland and Jeff O'Conner of San Elijo for coming to our Town Council meeting. (Do you

think they could talk to our County Supervisor and convince him it's not so bad?)

Town Center - Good news is that a Henrys/Trader Joe's type market is an option to the other "Big Three." Just the same, I'm glad San Elijo opened that door as do many other Elfin Forest and San Elijo residents. Also, Nona may get her bar but it may not open until Nancy's daughter is old enough to drink.

Sales - We have 421 new San Elijo neighbors. Projections were 1 sale a week, but sales were boosted after San Elijo was judged Master Planned Community of the Year by the National Association of Homebuilders.

Roads - SANDAG has tentatively granted San Marcos funding for a portion of Rancho Santa Fe (RSF) Road (Island to Melrose). Hopefully, permits are forthcoming or SANDAG will yank it for not being "ready to go." University Commons has taken over permits and construction of RSF Road (towards San Marcos) and the first segment of San Elijo Road widening. They applied for a 404 permit and hope to get it this month if Gnatcatchers are not nesting. Otherwise they will have to wait until the end of breeding season in August. Carlsbad's section of RSF Road has permits. To get updated on projections, I suggest we have University Commons out sometime soon. The Twin Oaks Valley Road connection is still in limbo. Right of way has been obtained, except for Byron White, who San Marcos does not feel will be a hindrance. Design is done, but no permits have been submitted and funding is still absent. San Elijo has been asked to hold that 404 permit application until University Commons permits are issued. Then, provided the permits and right of way are finalized, the roadway will be in position to apply for Regional funding. Still a long haul here.

Proposed Golf Course - San Elijo downsized roads when they "eliminated" golf course traffic and use in finalizing their plan and the ridgeline has always been a protected non-developable preserve. Switching the land use from Regional Hiking Park to developed course, clubhouse, and restaurant has created quite a stir in San Marcos. Meetings on it may start as early as June. I hope everyone will make the effort to become informed about details of the proposal.

Elfin Forest is NOT a Motocross Track

Elfin Forest is home to some of the finest stands of coastal chaparral remaining in Southern California. Its biological richness hosts many endangered species of plants and animals and conservation of this priceless treasure should be a priority for all of us.

During the past few months we've seen a dramatic increase in off-road motorcycle and quad runner activities on horse trails and water road easements. Motorized vehicles of any kind are not compatible with equestrian trails or endangered habitat. They destroy habitat and make the trails unsafe and unusable for horses. With the lack of rain this past winter, sparks from these vehicles present a HUGE FIRE DANGER. Their noise echoes through the valley and disturbs everyone within earshot.

Worse yet, some parents allow children to ride motorcycles alone on the trails. If your child were to be injured, how long could it be before you know about it? What might happen to your child who is vulnerable and alone on a trail?

All the land in Elfin Forest and the surrounding areas is privately owned and riders are trespassing. Many homeowners who have graciously made trails available across their properties have said they will block their trails if the motorcycle riding continues.

If you must ride, ride on your own property. We believe that the majority of riders are not from Elfin Forest and we should have **ZERO TOLERANCE** for this activity. One rider tells a friend who tells a friend, and soon, our valley is home to a continual motocross rally and we have no habitat or, for that matter, sanity left.

Please call the sheriff anytime you see this illegal activity. The sheriff has told us that even if they don't come out immediately, they make a note of the time and date of the incident and can use this information to determine trends. They then will make spontaneous visits when they predict riders are out. They are grateful for the calls they get from us.

So, dirt bikers and quad runner riders you've been warned. We're watching, we're reporting, and there's a HUGE FINE when you get caught.

Don't Be the Cause of a Fire!!

You don't have to have a match to start a fire! Every year people trying to eliminate their fire hazards by mowing start fires instead. Hot, dry, and windy weather are perfect conditions for a fire. Here's how to keep cool, eliminate the fire hazard, and prevent a fire:

1. Don't mow during the "heat of the day". Mow before 10:00 AM and after 6:00 PM. If it's too hot for you, it's too hot to mow.
2. Keep the mower, exhaust system, and spark arrester in proper working order and free of carbon buildup.
3. Use the recommended grade of fuel and don't top off.
4. Avoid *striking rocks with metal blades*. A grass-hidden rock is enough to start a fire.
5. Keep the engine and cooling fins free of oil and dust. It reduces the chance of a mower catching fire and lets the mower run cooler and last longer.
6. Keep the mower free of flammable materials. Check the grass outlet, around the blade, and the grass bag for obstructions.
7. Spark arresters are required on all portable gasoline powered equipment (Tractors, harvesters, chain saws, and mowers).
8. Grinding *and* welding operations require 10 feet of clearance and a fire extinguisher.
9. Keep a shovel and a fire extinguisher handy. Call 9-1-1, in case of a fire.

BEWARE – Lawn mowers are designed to mow lawns, not dry grass or weeds!

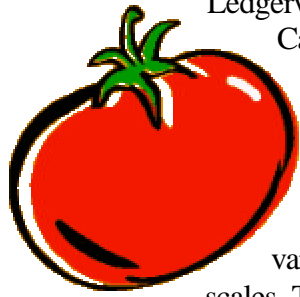

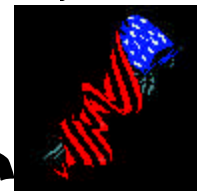
