Town Council Meeting – Wednesday, March 3<sup>rd</sup> @ 7:30PM At The Elfin Forest/Harmony Grove Fire Station

**Topics: Road Gating and Paving and Burglaries** 

#### **Election Results**

On February 4<sup>th</sup> elections were held for the Elfin Forest/Harmony Grove Town Council Board, the Elfin Forest/Harmony Fire Board of Directors, and the Elfin Forest Community Foundation.

Results of the Elfin Forest/Harmony Grove Town Council Board elections were as follows: incumbent Patti Newton was reelected to the Board with 36 votes; incumbent Evelyn Alemanni was reelected to the Board with 34 votes; Robert McGurk was elected to the Board with 39 votes; Greg Parman was elected to the Board with 34 votes; Jan Denny was elected to the Board with 30 votes; Terry Walsh, with 16 votes, was asked to be an at-large Town Council Board Member. The ballot initiative to allow that portion of Harmony Grove not currently in CSA 107 to be represented by the Elfin Forest/Harmony Grove Town Council passed with 22 Yes votes and 16 No votes.

The results of the Elfin Forest/Harmony Fire Board of Directors election were not received for inclusion in this issue of the *chaparral*. We hope to have it available for a future issue.

The three incumbent members of the board of the Elfin Forest Community Foundation (Mike Vallee, Frank Twohy, and Virginia McMannus) were reelected for subsequent terms.

#### Permit Renewal Pending For Fraternity House

An application for renewal of the conditional use permit for Fraternity House has been submitted to the city of San Marcos. The name is a euphemism as the facility is a home for AIDs patients. The notice sign was placed in an obscure location along Elfin Forest Road and only one person in the surrounding area received a Notice of Intent on January 21<sup>st</sup>.

Complaints and concerns about the Fraternity house need to be submitted in writing by March 1<sup>st</sup>. They are going through the review process as we speak. The more letters of concern that are submitted, the more effective they will be.

Fraternity House is a business run in our rural community. It leases the million-dollar San Diego County-owned house it uses as its facility for \$1 a year. With eight resident patients and attending staff the septic system is frequently overwhelmed. Our seasonal creeks have been polluted by Fraternity House. A large amount of traffic is sent through our community by buses taking resident patients to and from their doctor's appointments and by the people who work and visit Fraternity House. They show little regard for the speed limit or our equestrian pets.

Young families live in close proximity to the Fraternity House. Neighbors have tried to get information on the background of the men who live there. The people who oversee the house choose not to share any information about these individuals. Instead, they feel we should just trust their judgment as to whether or not these men are a threat to this community.

It's time to take our community back and put an end to this gross mismanagement of county properties! Take a look at the two other county owned homes next to the Fraternity House. It's pretty obvious the people overseeing these properties have little respect for this community and are no better then ghetto slumlords.

#### The School Yard By John Stiker

Welcome back to the School Yard! First important note: Our next meeting is on March 11<sup>th</sup> at 7PM (earlier than usual due to budget submission requirements). This week's column will just be a short recap of the issues discussed at the February 25<sup>th</sup> meeting. Reminder: Proposition K will be on your March 2<sup>nd</sup> ballot.

As we've shared, Prop K is our \$4.8 million "safety and repair" bond to conduct capital repairs on the R. Roger Rowe site. Key items that will be addressed in Proposition K include:

- Improvements in student safety at drop-off and pick-up
- Updating of fire, communication, and electrical systems
- Upgrading technology in the classrooms to 21<sup>st</sup> century standards
- Long-needed improvements to infrastructure such as sewer and water

Also included will be non-glamorous items such as continued compliance with the Americans with Disabilities Act (ADA), upgrading to current seismic standards, and restoring the site to its original state after the new school is built. The total assessment for Prop K is estimated to be less than \$7 per year for each \$100,000 of assessed value – a small price for important upgrades!

**Traffic at Quantum** – As we all know, the single biggest legitimate issue with the Quantum site for a second school is the traffic concerns on Del Dios. At our last board meeting in January, the traffic engineering firm Katz & Okitsu presented their initial survey results. While it appeared that the use of roundabouts did substantially relieve traffic on Del Dios and did enable us to mitigate the traffic impacts of a school to be opened at Quantum, we on the board (and many members of the audience) had a number of unresolved questions coming out of that study. On the 25<sup>th</sup>, we will see the next round of results on this study which should answer most if not all of those questions, as well as provide in-depth detail on the assumptions, terms, and impacts.

**Superintendent's Contract** - On the 25<sup>th</sup> the Board will be reviewing our three-year contract with Superintendent Vinson (due to expire at the end of this school year) and will decide what action to take going forward. This will be a closed session item and any action taken will be reported at the beginning of open session at 7PM.

**Next Steps** - *Please vote YES on Prop K!* And as always, we eagerly look forward to your comments and input by phone, email, or at our meeting on March 11<sup>th</sup>!

It's Gotta Stop!

Our community is a peaceful and beautiful place. SHAME on those who don't do their part to keep it that way. Here are some of the most recent nuisances. Let's all work together to make sure these activities are stopped. If you encounter an offender and have a digital camera, take a picture and email it to the newsletter editor and the sheriff. If you only have a pencil, jot down the vehicle license number and description. In any case, when you see something illegal or even questionable, call the sheriff. Don't wait for your neighbor to call. These illegal, criminal and annoying activities will continue as long as we allow them to by remaining idle.

**Burglaries** – During the period from February 16<sup>th</sup> through the 23<sup>rd</sup> three homes in Elfin Forest were burglarized. Two homes on Elfin Forest Road and one on Elfin Oaks. The break-ins occurred during the day when the residents were at work and the thieves took cameras, computers, jewelry, and money. This could be construction workers from the local mega-developments on their lunch breaks trying to supplement their incomes with your property. Keep your eyes open and your doors locked!

**Illegal Dumping -** At the beginning of February, someone dumped this load of concrete and construction materials on the unpaved portion of Questhaven Road. Within a few days, another load was dropped next to it.

This should be easy to spot and prevent. Make sure you record the license number of and any identifying information about the dumper's vehicle. Don't confront them, let the sheriff handle it. The penalties for illegal dumping are severe. **Motocross -** These off-road motorcycle riders are not just a public nuisance with the noise and dust they make. They frequently created a public safety hazard and liability by trespassing via the horse trails, private roads, County Water Authority and OMWD easements, and even through the chaparral. The riders ignore posted "no trespassing" and "no motorized vehicle" warnings. Their presence invites other illegal riders who see them racing along the roads.

If you see off-road motorcyclists traversing several properties (and regardless of what the riders might tell you) you can be sure that they are doing so without the permission of the property's owners. A check of neighbors found unanimous lack of consent.

Elfin Forest is not a motocross track. Let's not wait until someone is injured by or liable for the injury of trespassing off-road motorcyclists. Operating a motorized vehicle is NOT permitted on a community trail.

**Construction Vehicles -** The following email was received: "Heavy dirt/rock hauling trucks are coming through Elfin Forest from the east to the San Elijo school site. Also, I was behind a fuel truck barreling through Elfin Forest and spilling fuel all the way that pulled into the large empty lot just south of Elfin Forest Road, east of the San Elijo Hills town center! I took down license plate numbers and company names."

Remember, there are speed and weight limits on Elfin Forest and Harmony Grove Roads and construction traffic is prohibited from using Questhaven Road as a short cut to the San Elijo Hills and University Common developments in San Marcos. Don't let violators endanger us by tolerating their behavior.

#### Leave Me Alone

The Federal Telephone Consumer Protection Act of 1991 and Federal Communications Commission rules prohibit unsolicited advertisements, known as junk faxes, from being sent to fax machines at homes or businesses. Such faxes cost the recipients money for fax paper and toner. In spite of the prohibition, it was often ignored in California. That's because junk faxers cited a state law that permitted junk faxes as long as the fax itself included a toll-free phone number for a fax recipient to call to "opt out" of receiving faxes.

A bill that eradicated that loophole was initiated in 2002 by Assemblywoman Christine Kehoe, D-San Diego and the legislation was approved. The law making sure California's junk-fax law conforms with federal law went into effect in January 2003. Still, the junk faxes keep coming. Some of them have opt-out information on them, even though it doesn't matter anymore. The faxes shouldn't be sent, period.

One of the provisions of the Telephone Consumer Protection Act that was supposed to start in August was for marketers to get written permission from recipients before faxing unsolicited ads, even to those who had an "established" relationship with the faxer. A week before the rule was to go into effect, the FCC decided to delay the start date to January 2005. Many business and nonprofit groups complained that the written-permission rule would place an unreasonable burden on them.

Tom Dresslar, spokesman for the state Attorney General's Office, suggests taking these steps if you are receiving junk faxes:

- File a complaint with the attorney general's Public Inquiry Unit and the FCC. To file an online complaint with the Attorney General's Office, go to: <u>www.ag.ca.gov/consumers/mailform.html</u>. To file an online complaint with the FCC, go to: <u>www.fcc.gov/cgb/complaints.html</u>. You also can call the FCC's Consumer Center at 888-225-5322.
- File a complaint in Small Claims Court. Dresslar said individuals can sue for \$500 per violation, and up to \$1,500 per violation if the junk fax continued to be sent to you after you had asked a company to stop.
- He suggests keeping copies of all junk faxes you receive.
