Happy New Year everyone. Welcome to the first year of the new millennium. And once again, it seems to be open season on Elfin Forest and Harmony Grove by the developers.

At January's EF/HG Town Council meeting we heard from 'Coastal Farms' with their proposal to build 131 homes on the Altman's parcel adjoining San Elijo. Also, David Poole from Brookfield Homes briefed the audience on the latest developments with University Commons, the large parcel of undeveloped land between Rancho Santa Fe Road and San Elijo Hills in the City of San Marcos. In a few years it will be 800 homes plus expansion of light industrial around the existing La Costa Meadows industrial park. Over the next 2-3 years, Rancho Santa Fe Road will be re-aligned and widened between La Costa Avenue and just south of the fire station in San Marcos. Work will start in 3 or 4 months. During the same period, University Commons will start building out. This will include the re-alignment and widening of San Elijo Road (old Questhaven) between the San Elijo development and RSF Road.

What a mess it is all going to be! You think its frustrating now going through those silly stop signs in San Elijo? We have not seen anything yet!

Then on the east side of Elfin Forest, the Cielo Norte Specific Plan proposal is finishing up, getting ready for public review. Its 580 acres around the old trailer park and camp grounds consisting of 187 'clustered' homes. Most of them on 1/2 acre lots. See Chair, page 2

EF Community Foundation Projects

The Elfin Forest Community Foundation had received \$25,000 from CARE last July to spend specifically on trail systems and maintenance in the area. On the October 15th EFCF deadline a total of \$20,794 in trail proposals were requested, with \$19,794 approved.

These approved trail proposals include the Vorhees, and Kindel's on Fortuna del Este, the Zilka's from Fortuna del Norte to Cielo Azul, and bordering on

Elfin Forest Rd., and the Estrada/Dill proposal connecting Faraway Lane to Harmony Grove Road and Via Ambiente.

The Vorhees proposal and the grading for the Zilka proposal is already complete. It is very exciting to see so many community members motivated to initiate and oversee these proposals, and to make our area a more beautiful, safe and pristine place to live.

The Elfin Forest Trails Committee still oversees the money that is allotted for trail development. Checks from the Foundation are made out to the trails committee, rather than the individual, and the trails committee acts as a "fund" control for the projects and collects and maintains all receipts.

The next Foundation funding will be April 15th, 2001. There is still plenty of trails money available, as well as for other community projects. The current directors on the Foundation are Fred Moret, Frank Twohy, Virginia McMannus, Nicole Macaluso, Mike Vallee, Mary Moore, Martha Blane, Phillip Brailsford, and Steve Barker. Box builders | Volunteers do their part to help endangered owls

ESCONDIDO -- Everyone needs a home, and that includes the barn owl. Even though the predator is on the endangered species list, Pat Burke of Escondido is determined to ensure that the friend of the farmer is around for a long time to come.

Burke, a retired wildlife biologist, spends much of his retirement building barn owl boxes and spreading the word about the voracious owl's appetite for pests. "They do so much to keep our rodent population down," said Burke, 64. "They eat gophers, rats and mice. One owl can probably eat 1,000 a year." Burke should know. He spent 26 years working for the the U.S. Department of Agriculture Natural Resources Conservation Service (formerly the Soil Conservation Service). During that time, he was asked to come up with a design for the owl box. Since retiring in 1990, he has put a lot of time into making the boxes.

"The owl needs a cavity to live in," he said. "They usually live in hollows of trees, but they are being cut down for lumber, so they are disappearing because of development." If an owl is living in the wild, about three out of 10 survive. With a man-made box, the owl's survival rate increases to seven out of 10, Burke said. Burke and his friends Bob Limpus and John Sherman work on the boxes together. Limpus cuts and glues them and Burke paints them. Burke estimates there are about 1,000 boxes hanging in San Diego County.

"It's really a labor of love for us senior citizens," Burke said. "We sell them for \$35, and the money goes right back into the project. We get leftover wood materials donated from construction sites, but we have to buy staples, glue, paint and new saw blades."

Boxes must be up high in a tree and hanging on a branch away from the trunk. They can also be mounted on a 15- to 20-foot high pole. "If you mount on a pole, you must have at least 18 inches of metal sleeve around it," Limpus said. "This is a predator shield. Otherwise if you just put in on top of a pole, bobcats and raccoons can easily climb up the pole and get to the owl. If it's hanging in a tree, the box swings and an animal will not jump on something unstable."

Boxes usually last about 10 years. They are dark in color and should hang from either an oak or sycamore tree. "They have to be able to hold up in a storm," Burke said. "Pine trees break too easily, and citrus trees are too dense." Nesting materials such as straw or wood chips can be put in the box to help the owl get settled. "It can take quite a while for them to gather things to get it ready and they can have up to 11 babies," said Burke. "A good way to know the boxes are being used is to examine the ground below the box. You'll find where they have coughed up pellets. Owls cannot digest bone and they cough up about every six hours. This is how we find out about their food habits."

Burke often checks on some of the boxes in the area. So far, he hasn't noticed any other type of bird living in them, but two boxes were taken over by honeybees. "I really believe in this project because these birds are so good for our environment," Burke said. "I enjoy making the boxes and really enjoy the prospect of the owl finding a home."

EF/HG Town Council Forum - Jan 2000

ITEM #7: GP 2020: On Jan. 10, the County Board of Supervisors will host a workshop. Eric Anderson plans to attend, as does Nancy Reed. The county has offered to make a presentation to the community, one we will accept in the not-too-distant future.

ITEM #8: Terry Halbertson, Animal Control, has requested that interested parties participate in a fire drill in our area this coming April. They can "rescue" your animals or provide animals to you for that purpose. A number of residents have expressed interest -- the town council will contact Terry for more information.

ITEM #9: Nancy Reed is continuing to plan for a neighborhood "Tack Sale" to be held in conjunction with the fire auxiliary pancake breakfast in May.


ITEM #10: Town Council Nominations: There are two positions open on the town council board. Kim Hunter nominated Michael Garrison and Mid Hopenrath. Evelyn Alemanni nominated Bill Talecco. Their bios will be included in the Jan. Chaparral.

ITEM #10: Michael Garrison presented his proposed 40-acre development project called Redhawk. It is comprised of 13 lots (the 13th is a 13-acre parcel identified as mitigation for open space). Perc tests are being evaluated and the environmental issues are in process. Individual lots will be sold as custom home sites. Some deed restrictions will apply, e.g., a height limit is under consideration to disallow two-story dwellings.

ITEM #12: Pulte/Coastal Farms Proposal: Jim Simmons, Consultants Collaborative, represented Lou Sabatasso, Tom Utman of Pulte/Coastal Farms. The 69-acre parcel, currently owned by Max Altman, is adjacent to San Elijo Hills on the north side of Questhaven Road, and the proposed Quail Ridge project, to the south. The EIR in process deals with the original proposal for 264 homes. After exhaustive meetings with community representatives, the project being presented today is an alternative to that proposal which met with strenuous opposition. This plan proposes 131 homes on 25 acres (which would require annexation into San Marcos). The homes would be clustered adjacent to SEH; the remainder (45 acres) would be left as open space (presumably deeded to TECC) and would remain in the unincor-

porated area. This project would require acquisition of approximately 15 acres of coastal sage scrub, which the developer says, would be purchased in CSA 107 if available. In addition, the developer agreed to mitigate the loss of tax revenue to the EF/HG FD.

ITEM #13: Brookfield Homes/University Commons: David Poole represented the four property owners and updated the community on University Commons. In 1991, the San Marcos City Council approved the Tentative Map and the EIR for the project on 416 acres. After some background information, Poole presented the revised project. The business park (La Costa Meadows) will be expanded by 12 acres. There will be single family housing on the north and south sides, affordable housing, and a 33-acre park (where the existing "motocross" is), which abuts SEH. Although the owners prefer the previous, much higher density version, this alternative is being presented to San Marcos. To date, there are three plans, one with 1,700 dwelling units, one with 1,200 d/u, and one with 800 d/u. The third, Poole's plan, eliminated the commercial and added the industrial. The EIR is expected next month.

For those of you that did not attend the fabulous Elfin Forest Christmas Party last month, I am pleased to say that CARE has made a distribution of funds obtained from San Elijo Hills pursuant to CARE's settlement of its lawsuit. CARE was pleased to present \$45,000 to the Elfin Forest Fire Department to help with their equipment and other needs in the coming year, \$45,000 to TECC to assist it, and CARE gave \$10,000 to the Elfin Forest Foundation to fund a comprehensive landscaping plan for the beautification of the main roads that go through Elfin Forest. There is still some money in reserve to help fund the plan once it has been prepared, among other things. Since one of the key purposes of the CARE settlement is to provide funds to attempt to mitigate the impacts of the construction of the San Elijo Hills project on the community, CARE hopes that this first installment of funds made pursuant to the settlement agreement will be the first and visible step towards that goal.

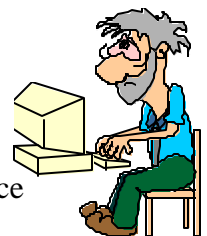

So far many have contacted us with their impressions and they have been overwhelmingly positive. A membership renewal/donation envelope was tucked in each copy for your convenience. We think 2001 is going to be a year of lots of news to report so be sure to watch the mail for the next issue and some good reading!

OTHER NEWS: Thanks to member Frank McCulloch the city of Escondido was "put on notice" in the year 2000 by the RWQCB for neglect of the creek (see our website for related articles). TECC continues to be in close contact with the RWQCB on this issue and others. Our dream is for a cooperative partnership with Escondido in 2001 and beyond. It will be a challenge but one TECC feels is vital to the health of the creek. On the land acquisition front, last year TECC collaborated with County Parks & Rec. and a TEA (Transportation Enhancement Act) grant was awarded (actually to the county) for the purchase of land within the Escondido Creek watershed. Pam Slater was the guiding light behind this endeavor. With TECC's guidance, the Department of Parks & Rec. is looking for suitable parcels to purchase. We will keep you updated. The TECC owned Buman property is sporting some new preserve signs purchased with a grant from Volvo. We are also applying for a grant to restore this lovely creek property. TECC continues to be involved with discussion on receiving mitigation lands.

Pam Slater has a strong interest in our watershed, so in December 2000 TECC took her aid, Sachiko Kohatsu, who is impressively knowledgeable in "all things water quality", on a 3-hour tour of Escondido Creek. It was a beautiful day and a successful tour. We included the good & beautiful along with the bad & ugly (as in channelized & trash filled creek). Supervisor Slater would like to apply for grants to enhance the creek and has also been sending competent and talented folks our way for future projects. TECC is also involved with the Southern California Wetlands Recovery Project (more about this and

other TECC partners next month) which Slater co-chairs.

Remember Prop 13 (the Costa-Machado Water Act of 2000) that TECC asked you to support? It was passed on the March 2000 ballot. Round one (which is the only chance for planning money- all other cycles will be for implementation monies) is underway. TECC has partnered with The San Elijo Lagoon Conservancy and we are applying for a watershed management plan grant. The entire Escondido Creek watershed (which is 77 square miles and extends from above Lake Wohlford to the San Elijo Lagoon) will be addressed in this plan. It would be incredible if we receive this grant. However if we do not, we have begun the New Year with a new partner and one with immeasurable knowledge and resources.

Speaking of grants, I put a notice in last month's Chaparral for volunteers- specifically grant writers. Ask and ye shall receive! We now have Nancy Reed and Ann Becke-Witte "on board" as active TECC volunteers. Thanks to both these talented women for responding. How about you? Everyone has some talent that can be put to use. Future specific volunteer needs will be listed here, but in the meantime call TECC @ 760-471-9354 and let's talk about how you can help now.
