From The Chair

Happy winter to all. It sure is nice to have a normal rainy season, the hills are getting green without the washed out roads of El Ninos past.

Last month I described to you some of the development activity surrounding Elfin Forest and Harmony Grove. Well I left out some. Recently Carlsbad release a draft EIR (Environmental Impact Report) concerning a new project to the west of us named the Villages of La Costa, Master Plan MP 98-01. The draft EIR was issued on January 25, 2001.

The project is vast, located in the southeastern quadrant of the City of Carlsbad. Generally located south of Palomar Airport Road, east of El Camino Real, north and east of La Costa Avenue, and straddles portions of Rancho Santa Fe Road.

The project is described as having 2390 DUs (dwelling units) of various product types and lot sizes, a 7.9 acre business park, two community facilities sites, a community park site, an elementary school site and the preservation of 835.4 acres to open space of the total 1866.4 acres.

Before reviewing the EIR document thoroughly, the Elfin Forest/Harmony Groves concerns are the impact of the far easterly sections of the project known as La Costa Ridge and La Costa Oaks that straddle Rancho Santa Fe Road north of La Costa Avenue and south of Alga Road. Future residents of this area will more than likely use EF/HG Roads to go east to Escondido and beyond. These parcels border on open space contiguous with Elfin Forest, and

will add light, air and noise pollution to the western portion of Elfin Forest.

Other projects I omitted last month include Cielo, 528 homes on 1750 acres that border to the south east of us. Officially in the Escondido and Rancho Santa Fe service districts, ridges to the east of Elfin Forest that are currently being cut and filled are the highest elevations of this project. Main access is from Del Dios highway and future access will be from Via Ambiente (the dam construction road) at Harmony Grove Road.

Another project that borders to the south in Rancho Santa Fe is The Bridges, 205 homes and a golf course on 700 acres that straddles the Escondido Creek.

Our neighbors in Eden Valley have to look forward to a power generating plant to be built in the yet to be developed Quail Hills Industrial Park in Escondido.

Please attend the March EF/HG Town Council meeting. Our special guests will be representatives from our local north county California Highway Patrol office to discuss their traffic law enforcement activities in our community.

Questions and comments from the audience will be welcome. Please come on by, 7:00 P.M., Wednesday, March 8.

'Butterfly' film showing in Carlsbad

On a cold December morning in 1997, Julia "Butterfly" Hill ascended a 180-foot redwood tree named 'Luna' to protest the logging of Northern California's forests. For the next two years, the tree became her home. The world was later shocked to learn that Luna was savagely cut and mortally wounded by vandals in November, 2000. Butterfly, directed by Doug Wolens, tells the story of a remarkable young woman who became a hero to environmentalists and a pariah to the logging industry. While Butterfly focuses its attention on Hill, the real "star" is the community of Humboldt County where residents found themselves at the epicenter of a national debate. Tonight's film is the 80 minute feature-length version of the 1 hour program originally aired last June on PBS. When I was a puppy, I entertained you with my antics and made you laugh. You called me your child, and despite a number of chewed shoes and a couple of murdered throw pillows, I became your best friend. Whenever I was bad, you'd shake your finger at me and ask How could you? - but then you'd relent, and roll me over for a belly rub.

My housebreaking took a little longer than expected, because you were terribly busy, but we worked on that together. I remember those nights of nuzzling you in bed and listening to your confidences and secret dreams, and I believed that life could not be any more perfect. We went for long walks and runs in the park, car rides, stops for ice cream (I only got the cone because ice cream is bad for dogs, you said), and I took long naps in the sun waiting for you to come home at the end of the day.

Gradually, you began spending more time at work and on your career, and more time searching for a human mate. I waited for you patiently, comforted you through heartbreaks and disappointments, never chided you about bad decisions, and romped with glee at your homecomings, and when you fell in love.

She, now your wife, is not a dog person - still I welcomed her into our home, tried to show her affection, and obeyed her. I was happy because you were happy. Then the human babies came along and I shared your excitement. I was fascinated by their pinkness, how they smelled, and I wanted to mother them, too. Only she and you worried that I might hurt them, and I spent most of my time banished to another room, or to a dog crate. Oh, how I wanted to love them, but I became a prisoner of love.

As they began to grow, I became their friend. They clung to my fur and pulled themselves up on wobbly legs, poked fingers in my eyes, investigated my ears, and gave me kisses on my nose. I loved everything about them and their touch - because your touch was now so infrequent - and I would have defended them with my life if need be.

I would sneak into their beds and listen to their worries and secret dreams, and together we waited for the sound of your car in the driveway. There had been a time, when others asked you if you had a dog, that you produced a photo of me from your wallet

and told them stories about me. These past few years, you just answered yes and changed the subject. I had gone from being your dog to just a dog, and you resented every expenditure on my behalf.

Now, you have a new career opportunity in another city, and you and they will be moving to an apartment that does not allow pets. You've made the right decision for your family, but there was a time when I was your only family.

I was excited about the car ride until we arrived at the animal shelter. It smelled of dogs and cats, of fear, of hopelessness. You filled out the paperwork and said I know you will find a good home for her. They shrugged and gave you a pained look. They understand the realities facing a middle-aged dog, even one with papers. You had to pry your son's fingers loose from my collar as he screamed No, Daddy! Please don't let them take my dog! And I worried for him, and what lessons you had just taught him about friendship and loyalty, about love and responsibility, and about respect for all life. You gave me a good-bye pat on the head, avoided my eyes, and politely refused to take my collar and leash with you. You had a deadline to meet and now I have one, too.

After you left, the two nice ladies said you probably knew about your upcoming move months ago and made no attempt to find me another good home. They shook their heads and asked How could you?

They are as attentive to us here in the shelter as their busy schedules allow. They feed us, of course, but I lost my appetite days ago. At first, whenever anyone passed my pen, I rushed to the front, hoping it was you - that you had changed your mind - that this was all a bad dream...or I hoped it would at least be someone who cared, anyone who might save me. When I realized I could not compete with the frolicking for attention of happy puppies, oblivious to their own fate, I retreated to a far corner and waited.

I heard her footsteps as she came for me at the end of the day, and I padded along the aisle after her to a separate room. A blissfully quiet room. She placed me on the table and rubbed my ears, and told me not to worry. My heart pounded in anticipation of what was to come, but there was also a sense of relief. The prisoner of love had run out of days. As is my nature, I was more concerned about her. The burden which she bears weighs heavily on her, and I know that, the same way I knew your every mood.

She gently placed a tourniquet around my foreleg as a tear ran down her cheek. I licked her hand in the same way I used to comfort you so many years ago. She expertly slid the hypodermic needle into my vein. As I felt the sting and the cool liquid coursing through my body, I lay down sleepily, looked into her kind eyes and murmured How could you?

Perhaps because she understood my dogspeak, she said I'm so sorry. She hugged me, and hurriedly explained it was her job to make sure I went to a better place, where I wouldn't be ignored or abused or abandoned, or have to fend for myself - a place of love and light so very different from this earthly place. And with my last bit of energy, I tried to convey to her with a thump of my tail that my How could you? was not directed at her. It was you, My Beloved Master, I was thinking of. I will think of you and wait for you forever.

May everyone in your life continue to show you so much loyalty. The End

San Elijo Golf Course Update

Today I learned that the SM Planning Commission will decide the fate of the proposed San Elijo Hills' ridge line golf course. However, their decision can be appealed to the City Council.

I propose a campaign to raise community awareness. There are four potential groups which must work together to increase awareness: First, and most importantly, the voters of San Marcos. Two other prominent groups include the concerned residents of Lake San Marcos and the citizens living in and around Elfin Forest. Finally, we hope that regional supporters who enjoy trails and golf-course-free-ridge lines will join the effort. I need your help to do this.

*The first step in preserving the ridge line's natural open space is raising community awareness.

*The Friends group does not oppose a San Elijo Hills' golf course, but adamantly opposes the new location for several important reasons:

1. The golf course does not adhere to the city's original specific plan and would relocate the existing trail.
2. Significant grading would take place with substantial damage to the natural environment.

3. Initially, the run-off would include silt, but later would contain pesticide and fertilizer residues.

4. Pumping precious water up the mountain will be very expensive.

5. Add your own negative impacts to this list.

Where should we begin? Start talking to everyone you know - especially Voters in San Marcos. Write letters frequently to the editor, and city council members. Share any other suggestions and ideas with me. Let's spread the word!

Meet with the Friends group later in March to formally kick off our campaign, climb Double Peak and hike part of the ridge line. Stay tuned for more info.

TECC partnerships

The Escondido Creek Conservancy is a small but integral part of a larger matrix comprised of an array of community and watershed partners. Working together gives us each a more powerful voice, provides a vast diversity of human resources, and covers a much greater geographic area. In this way there are no “islands”, but rather a comprehensive group of interconnected environments, which can be intelligently planned and protected. In the constantly changing watershed community, no one can afford to work in a vacuum. Through partnerships information & ideas are exchanged, grant applications are co-written, and valuable equipment & resources, such as GIS, are shared.

January 2001 marked the beginning of a new cooperation and partnership with the San Elijo Lagoon Foundation (SELC). This lagoon is at the end point of the Escondido Creek Watershed. SELC has recently begun looking/thinking upstream & through a Ford grant was able to purchase property close to the La Bajada Bridge. What happens at the top of the watershed (Lake Wohlford) affects everything good or bad that happens downstream. Therefore it is natural to work as a team and focus efforts on the entire watershed. For starters, TECC & SELC formed a partnership to facilitate improved performance of the structure and ecological functioning of the Escondido Creek watershed. This was done by submitting a grant application for Prop 13 funds to prepare a focused watershed management/action plan. Our plan is to continue working together in the future.

TECC is an active member of The Carlsbad Watershed Network; a watershed coalition including the Resource Conservation District of Greater San Diego County, Buena Vista Lagoon Foundation, Agua Addenda Lagoon Foundation, Batiquitos Lagoon Foundation, and the San Elijo Lagoon Conservancy. The entire watershed is called the Carlsbad Hydrologic Unit encompassing 210 square miles. Using a watershed approach the CWN coordinates habitat protection and improvement on a regional basis. Members share resources and work jointly to apply for grants and implement natural

resource projects in three areas of common interest: Habitat Restoration and Protection, Water Quality, and Public Access and Education. This forum is unique in bringing together a diverse group of individuals and groups facilitating networking and greater understanding of each other's individual and similar problems and goals.

General group meetings are held monthly to plan, educate, and tackle pending issues like new legislation, invasive plant removal, and water quality issues. There is also the opportunity for participation in sub-committee work. Advisory members include the California Coastal Conservancy, San Diego Association of Governments, the Regional Water Quality Control Board, the UC Natural Reserve System, and the Canyons Network. All municipalities within the CWN are invited to participate; to date, Carlsbad, Vista, and Encinitas, and Oceanside are active.

Whether the focus is on children or property owners, watershed education is key to any project we undertake. To encourage this, the educational subcommittee has formed an alliance with members of the San Diego Natural History Museum, Sea World, National Marines Fishery, the Cleveland National Forest, and others.

The Coalition of Environmental Organizations currently includes TECC, Palomar Audubon Society, Escondido Citizens Ecology Committee, San Dieguito River Park, League of Women Voters, Sierra Club, and Friends of Daley Ranch. Representatives attend BI-monthly meetings with the City of Escondido Planning Department to keep current on issues such as General Plan updates, to learn about new or pending projects, and to voice individual concerns.

TECC is also a member of the San Diego Land Conservancy Coalition, which is a clearinghouse for mitigation land opportunities. TECC is also an active member of the National Land Trust Alliance.

The Southern California Wetlands Recovery Project is another unique alliance of federal, state, and local officials working in concert with businesses and nonprofit organizations. Its goals are wetland acquisition and restoration with a visionary, long-term regional approach. TECC staff and directors participate in monthly meetings, symposiums, and special sessions for grant application planning. This group is co-chaired by Supervisor Pam Slater and SELC Executive Director, Doug Gibson.

Two members represented TECC at the National Watershed Outreach Conference in San Diego in April 2000. So you can see, TECC does more than pick up trash and ask for donations! We are active members of a diversified watershed community. For the future, TECC is committed to more cooperation and partnering in order to meet our goals.
