June EF/HG Forum Minutes

DATE: June 17, 2001

OPEN FORUM: Evelyn Alemanni passed out ballots for the 26th annual “Orchids and Onions” awards, organized by volunteers from a host of professional design organizations to sharpen public antennae and encourage discussion about what constitutes “good” regional or urban planning, design and good solutions to environmental problems. Marty Benowitz encouraged anyone interested in volunteering for Fourth of July picnic tasks to call him at work 591-9700 or at home 591-4404. Joan Hershfeld announced the fire auxiliary meeting is next Weds. At 7 p.m. for those interested in participating. Kevin Barnard, of Harmony Grove, presented the Power Point program prepared for LAFCO (Land Agency Formation Commission) regarding the industrialization of 900 acres in the area. The Harmony Grove/Eden Valley Citizens Group was formed to create a planning group because it was excluded any county planning group's area of concern. Another issue of concern is HG's area is split between two supervisorial districts

(Slater and Horn). An effort is underway to incorporate the area into Slater's district. Redistricting is currently under revision. There is a need to create a more unified coalition of area groups, i.e., EF/HG Town Council, Eden Valley, and HG to represent community concerns and interests. A coalescing of these entities would result in a more powerful political body. Incorporation of the HG name into the EF Town Council was a recent first step toward that end. Sue Varty discussed the OMWD's proposed rate reductions and why she is opposed to the plan. Sue thinks the plan, as proposed, is unfair because it forces owners of larger parcels (like EF) to subsidize others. There is little, if any benefit to EF residents. Because the bulk of rate payers who benefit in the four other districts, it is unlikely Sue's vote will have any influence.

ITEM 1.: The Elfin Forest/Harmony Grove Fire Department, and its consultant, Greg Lowry, presented its position on Proposition S. On July 24, 2001, the EF/HG FD will ask CSA 107 voters to approve an annual increase in the existing Special Tax Rate. If passed, it will become effective on July 1, 2001 and continue escalating each year through June 30, 2015. Benefit units (in the amount of \$8.50/acre) will be capped at an eight-acre maximum. In the first year, the tax rate will be \$34/benefit unit. The second year it will double to \$68, year three will triple to \$204; until by year 15, the amount will max out at \$510 annually thereafter. Frank Twohy and Nona Barker explained the department's rationale for the funding. Among the reasons, the area is a prime target for annexation by surrounding cities, an issue the community has vigorously fought off in the past. Cities will attack essential services first; a volunteer fire department is perceived as a weakness. The City of San Marcos has told LAFCO the EF/HG

FD is not able to respond to emergency incidents in a timely manner. It positions itself as better equipped to manage the CSA. Twohy and Barker agree that approval of Proposition S sends a message that the community is willing and able to fund its own services, negating the need for outside services. Other benefits of the plan as described by the EF/HG FD are: Preservation of the quality of the community's rural atmosphere; ensures the continuity of the EF/HG communities; enhanced delivery of fire and emergency medical services; provides state-of-the-art fire apparatus and advanced medical equipment; provides 24/7 staffing of the department; helps maintain property values; assist in reducing insurance premiums; contributes to faster response times; facilitates advanced training of staff.

Equestrian Manners

A person who recently moved to Elfin Forest was heard telling someone, "This is an equestrian community and that means I can ride wherever I want." As a long time Elfin Forest resident, this is news to me.

Many community members have worked with the trails committee and the Elfin Forest Foundation to create trails, and private home owners have dedicated easements through their properties to avoid the problems of trespassing. Fortunately, most of our equestrians are thoughtful and respectful people who would never consider riding across anyone else's property without permission.

But there are some who think nothing of riding on other people's driveways, garden paths, private roads and "dropping a load" without so much as a "do you mind if I...." Others have gone riding equipped with wire cutters and bolt cutters to compromise the integrity of fences. You know who you are. Please don't spoil it for everyone. The whole community will appreciate your thoughtfulness when you're careful and respectful not only of property rights, but of other people's privacy when you ride.

Just another thought: if you use the trails, please consider donating some of your time and materials to help maintain them.

Rancho Santa Fe Opposes Vacation of Elfin Forest Rd. Easements

For more than two years, the town council has been working with the county to vacate the easements of Elfin Forest Rd. that permit it to be widened to 4 lanes. We do not need more than 2 lanes. Harmony Grove Rd. should not be widened due to its topography, biology, and proximity to the creek. The county completed a study supporting this action.

The May 10 issue of the Rancho Santa Fe Review contained an article stating that the RSF Association strongly opposes the reclassification of the roadways. Jim Ashcraft, chairman of the association's road and traffic committee said, "The Association is vigorously opposing this action because maintaining

the surviving remnants of an already severely inadequate roadway circulation system is crucial to this community as well as to the entire mid-North County area. Given the vast number of already approved developments in the area of Elfin Forest, it is in insanity to eliminate critically needed planned future roadway improvements. He urged those who oppose the vacation of the easements to write to San Dieguito Planning Group chair, Ken King, POB 2798, RSF, 92067.

It is galling that the developers who live in RSF and are largely responsible for creating the traffic mess by not paying their share of infrastructure costs are promoting the destruction of our community. Please, take the time to write to Ken King at the address above to support keeping Elfin Forest Rd. as it is, and vacating the easements.

TECC receives Grant for \$16,390.00

TECC has once again been the fortunate recipient of a grant. This one is for \$16,390.00 and will be used for planning on the newly acquired 76- acre preserve.

The grantor is The San Diego Foundation Blasker Rose-Miah Fund. The money will be used to conduct a biological survey to inventory and map the existing natural resources of the recently acquired 76-acre Escondido Creek Preserve; To prepare an enhancement plan for the degraded habitat within the 76-acre parcel; and to prepare a long-term habitat management plan for the 76-acre parcel and Escondido Creek natural corridor.

The San Diego Foundation has been very good to TECC and once again we thank them from the bottom of our hearts. Thanks also to our dynamic duo-Martha Blane & Ann Beck-Witte- for their volunteer efforts in successfully writing the grant!

What is CSA 107?

If you look on your property tax bill you'll see on the right a box stating all the different taxes that your property tax bill includes. Look for CSA 107.

CSA stands for County Service Area. A County Service Area is an Unincorporated area of San Diego County with a special tax attached to it. Our area is designated # 107.

County Service Area 107 is your fire department and only your fire department. Not San Marcos, not Escondido City. Yours. Elfin Forest and Harmony Grove!

County Service Area 107 is:

- 1) the legal boundary of the Elfin Forest/Harmony Grove area
- 2) the legal boundary of the Elfin Forest/Harmony Grove Fire Department
- 3) the mechanism the local voters approved in 1982 to collect the special benefit tax for the Elfin Forest/Harmony Grove Fire Department.

How it works:

Every April and December you pay your property tax. The portion of your property tax bill collected for County Service Area (CSA) 107 is put in a County of San Diego special fund. This fund is managed by the Special Districts Department of the County of San Diego.

Each month, the Elfin Forest/Harmony Grove Fire Department submits a claim form to Special Districts for money spent. Each month the Elfin Forest/Harmony Grove Fire Department receives a check back from Special Districts.


