The search goes on for one or more new school sites in Elfin Forest for the Rancho Santa Fe school district.



This can be used as one full page, two half pages, four quarter pages, etc. Additional advertising after the free page is available at a 25% discount.

Price Increase for Newsletter

Despite increases in the cost of supplies and postage, we've worked hard to avoid increases. However, the Board has decided, effective June 29, 2004, to increase the subscription price to \$20 per year. What's Happening At The Fire Department: July 2004

- The multi-agency wildland drill at the end of June completes our initial our wildland training, and we put on quite a show for our residents. Engines from Rancho Santa Fe, San Pasqual and Elfin Forest combined with County Copter 1 for a wildland scenario of a vegetation fire requiring structure protection, progressive hoselays, and helicopter water drops. Training of this type helps us to prepare for a wildfire here in Elfin Forest. An excellent drill and many thanks to all the agencies attending.
- Training this month will focus on using our new Impact Gas Detector and Bullard Thermal Imager. These two new pieces of equipment greatly enhance our abilities in structure fires, confined space, and hazardous materials incidents. Additionally, we will train and re-certify on the Automatic External Defibrillator and Combitude.
- Our new Brush 2861 is ready for fire season. Lots of work by the Apparatus Committee and in particular Bob Kephart and Tim Costanzo have laid out things to make use of equipment simple and quick. Recent drills with outside agencies have helped us to refine equipment placement.
- Brush 2861 is on a strike team assignment on the Mataguay Fire. Captain John Rayes is leading his crew. Crew is Driver Operator Mike Shea, Firefighters Joy Schuler and Trevor Whitehead.
- Grant opportunities continue. An application has been submitted to CDF for a new Type 3 Wildland Engine. If approved, it would allow us the opportunity to replace our old and outdated 1979 GMC that does not currently meet NFPA standards. Also, an application is being prepared for a grant available from the Fire Foundation for medical equipment or training needs.
- The Annual Elfin Forest/Harmony Grove 4th of July Parade and Picnic was a success as always. The Department participated with our equipment and support. Annual service awards were presented, including Firefighter of the Year to Firefighter Ryan Parker, an extraordinary young man who exemplifies the qualities of what makes our Department so special. Demonstrations of the new Bullard Thermal imager purchased on a grant from Firemans Fund were well received by the community.

Minutes Of Elfin Forest/Harmony Grove Town Council Meeting

DATE: July 7, 2004

CALL TO ORDER: 7:35 PM

UPDATES: Bob McGurk gave the treasurer's report. The town council received \$2,962 in income (primarily from Community Guides) and expended \$693.41, resulting in a net income of \$2,269.

Item #1: Paul Davy, Supervising Agricultural Inspector, Agricultural Water Quality (County of San Diego), discussed storm water and other water quality issues, especially those relating to rural residential living. He discussed the historical aspects of water management, i.e., the Clean Water Act and the role of the Regional Water Quality Control Boards in adopting and implementing discharge requirements and regulations for runoff.

Urbanization has contributed to degradation of waterways, and subsequently the ocean due to pollutants like oil, feces, erosion, etc. These pollutants contain sediment, heavy metals, and pathogens. Two of the most offensive activities in the county are washing cars and horses without properly managing the wastewater. Oftentimes people and businesses fail to recognize their roles in creating such pollution because of poor water management practices and fail to understand that storm drains empty directly into the ocean, not into water treatment facilities. Regulations require best management practices (BMPs) be implemented, e.g., installing holding tanks in horse wash rack areas, silt retaining fencing, and runoff retention basins. County residents are encouraged to report any significant spills by calling 888-846-0800. The county inspects on a complaint basis (reactive rather than proactive). You can learn more by visiting the county web page at sdcounty.ca.gov/dpw/watersheds to view the storm water ordinance. Paul distributed an excellent brochure entitled *Equestrian –Related Water Quality Best Management Practices*, a cooperative effort among private and public entities in Orange and San Diego Counties in response to NPDES permits issued by the Santa Ana and San Diego RWQCBs. Another brochure, *Water Quality Management Practices at Equestrian Facilities* explains how equine facilities affect water quality. Both are excellent resources to guide residents in ensuring they are not harming our environment with

careless manure disposal methods such as spreading manure on hillsides above watersheds, a clear violation.

Item #2: Ted Marioncelli, representing Cingular Wireless explained a proposal for a cell site located at the Selvig residence, 19914 Elfin Forest Lane. The tower is disguised as a broad leaf tree. The noise level is no higher than 35 decibels.

Item #3: Jim Depolo discussed the RSF school district will not be putting a bond on the ballot this November because there is not enough substantive information at this time. Many details remain in flux. The current principal has left, and the school is actively seeking qualified candidates to fill the position. The search for a replacement Superintendent is on going. Because three of five school board seats are up for re-election this year, they will wait to permanently fill these positions until the new board is in place.

Mid Hoppenrath discussed the potential location for a new Escondido High School being proposed for the Eden Valley/Harmony Grove areas. The district is looking at approximately 60 acres at Citracado past the two mobile home parks near the HARRF (this is speculative since we don't really know the exact location at this time). Another potential site is at Avenida del Diablo near Country Club and Surrey Lane. There are several large undeveloped properties in this area which may qualify for consideration. The district plans an Aug. 3rd meeting to narrow the site locations to two or three qualified sites. Apparently the district already has the funding for acquisition but would still need to issue a bond for construction. Impacts to the community were discussed; the TC will develop a position paper and Mid Hoppenrath will present it during the Aug. 3rd meeting. A strong showing of residents expressing their concerns is vital at this stage so that we get in on the bottom floor so to speak.

OPEN FORUM: Comments regarding the Notice of Preparation (NOP) for New Urban West's (NUW) EIR are due Aug. 2nd at 4 PM. The TC will hold a community workshop to develop information.

The county will hold a public meeting July 19th at the firehouse to take input on the NUW project.

The Bridges construction cut-through traffic seems to be increasing on Fortuna del Este. The TC may write a letter if Greg Parman does not gain any results from a call to the superintendent of construction.

Do you realize that the Escondido High School District is considering putting a new high school for 2000+ students at the end of Surrey Lane in Eden Valley? Eden Valley Community Character - Located in unincorporated San Diego County, Eden Valley is rural in nature, extremely quiet, peaceful, and generally remains in its natural state. The area is single-family rural residential and agricultural in usage, with large lots, residential livestock

keeping; equestrian trails, and the dark night sky is an important aesthetic resource.

There is one main roadway in Eden Valley, Country Club Drive, which is a two-lane, tree-lined residential street with commercial weight limits and is designated as a traffic calming area. The roadside is often used as a multi-use equestrian trail by the residents. There is no commercial development; no sewer, no street lights, no traffic lights, no lighted signs, no traffic signals, no curbs, no sidewalks, no extractive land uses, and no commercial or non-agricultural industry in Eden Valley. Residents here value open space, quiet, dark nighttime skies, low traffic volume, equestrian trails and access to the abundant wildlife that flourishes in this beautiful rural environment.

Protecting our Water Resources Adapted from a County Publication

Did you know that horse facilities can impact water quality? A brochure provided by the County of San Diego Department of Agriculture, Weights and Measures, provides detailed information. You can retrieve it online at: sdcounty.ca.gov/dpw/watersheds, or contact the University of California Cooperative Extension at 858-694-2845.

Horse wastes including manure, urine, and soiled bedding have biological and chemical properties that can be harmful to plants, animals and people. Nutrients in horse feed return to the environment in feces and urine. If transported by storm water or runoff to watercourses, these materials can produce large amounts of algae, called blooms. These blooms consume dissolved oxygen in the water. Ammonia is a by-product of urine. A very small amount of ammonia in water can kill fish. Salts are contained in all animal waste. Salts do not break down and can be carried by runoff into local surface and groundwater, where it can have harmful impacts on plants and aquatic organisms. Salts can make water undrinkable and very salty water can harm irrigated crops.

Bacteria and viruses in manure can be a health threat to humans, other horses and wildlife. Fecal coli form in manure can travel through water courses to our beaches where it can make people sick.

The Management and Discharge Control Ordinance prohibits the discharge of contaminants from horse and confined animal facilities. The ordinance also requires the implementation of Best Management Practices at these facilities. The following are examples of requirements generally found in storm water and runoff regulations:

1. Manure from confined livestock, horses or other large animals which could enter receiving waters or the storm water conveyance system (drainage ditches, gutters, creeks, etc.) must be cleaned at least twice weekly and either be composted or be stored (prior to disposal) in a manner that prevents contact with runoff.
2. Areas used for composting manure must be located, configured or managed to prevent runoff to receiving waters, or the storm water conveyance system.

3. Pet waste can not be allowed to enter the storm water conveyance system or receiving waters. Clean up after your animals.
4. Animal wash racks at equestrian facilities may not discharge to the storm water conveyance system or receiving waters.
