Not All Golf Course's Are Created Equal.

Many of you have received a notice of intent from San Marcos about the proposed golf course at San Elijo Hills. While on the face of it, this might sound like a nice addition to the project, there are some serious impact to consider...

Pollution of tributaries, waterways and elfin forest wells, including questhaven retreat

Expanses of year-round perfectly green, weed and pest free fairways and greens mean heavy use of chemicals, pesticides, poisons, and fertilizers. Statistically, courses use minimally a half ton of pesticides a year. On average, golf courses use three times as much pesticide as do farms. Pesticides aside, even nitrogen is deadly to add to waterways and natural habitats. Coupled with full time irrigation and an underlayment of rocky clay soil, which promotes both leaching and runoff, San Elijo's golf course could feed devastating amounts of toxins into our numerous waterways. Not only are San Marcos Creek and Escondido Creek linked to this mountain location, but Elfin Forest well water is also fed from there.

Personally, I think Elfin Forest owes much of its rural character to The Questhaven Retreat, who has fought many expensive battles for our benefit. The Retreat, right below San Elijo, operates totally on well water. Elfin Forest owes it to ourselves and our future to assure all our wells and waterways remain healthy.

Double cross history

San Elijo hoodwinked their way into approval for 1200 additional units, commercial etc., and down sizing Elfin Forest Rd., under the pretext of eliminating the golf course from original plans. Yet here it slinks back, in a much deadlier location.

The now dead 1990 San Elijo EIR, covered a project with a golf course at lower elevation, with NO commercial or institutional. That original golf course plan was approved for 2300 homes, a 6 lane highway connection to Twin Oaks Valley Rd., widened habitat corridors and elimination of all grading on the upper ridge line. That plan met with the approval of the then Elfin Forest subcommittee. San Elijo subsequently decided not to proceed with those approvals, primarily saying they had decided to drop the golf course.

The 1995 EIR (released in 1997 & covering the current project), requested an increase to 3398 homes, reduction in the 6 lane highway to 4 lanes, and addition of commercial and institutional, primarily due to ELIMINATION of the golf course and related facilities from the new plan.

Consequently, the developable space, where the forsaken golf course once was, is now crammed with approved wall-to-wall buildings, pavement, and postage stamp lots.

San Elijo is not giving up one home site, parking lot or anything else to now add back a golf course, related facilities and all their impacts. Instead, the new golf course is proposed to eliminate mountain top natural open space lands. Fairness dictates that the course and facilities, if resurrected, should return to the buildable envelope by eliminating the add-on 1200 units, etc. that were gained by its previous elimination.

Destruction and defacement of the primary ridge line

Primary ridges with their highly visible natural curves are protected by San Marcos' general plan, except in San Elijo. Go Figure. Only San Elijo gets the special privilege of flattening San Marcos mountains.

Loss of regional natural park

The course is proposed on natural open space land, that currently contains plans for hiking/equestrian trails and overlooks through natural habitat, similar to Nature park off Harmony Grove Rd. We Elfs especially know the value of such regional parks.? Do we want to trade equestrian open space for a graded ridge line topped with 10-12,000 sq. ft. club-houses and related buildings?

Destruction and fragmentation of core habitat

Eliminating habitat destroys sensitive species, while forcing San Elijo's hardier species (deer, coyote, snakes, rats, etc.) to move our way. Our coyote etc. problems of today are nothing compared to what we will experience if further natural habitat is lost to manicured fairways, golfers, and lawn mowers.

MORE TRAFFIC The roads cannot handle what is already planned. San Elijo has reduced improvement plans for Rancho Santa Fe Rd. and San Elijo Rd. from 6 lanes to 4 lanes, while steadily increasing their traffic impacts. Gridlock is already approved

within existing plans. The proposition of adding course traffic is insult to injury.

What does related facilities mean?

Is San Elijo or San Marcos capable of taking a conservative view to development? The term Related Facilities when used by San Elijo makes my hair stand on end. Is San Elijo marketing green fairways, while hotels, spas, tennis and swim facilities, restaurants, bars, and night clubs dance in their head?

Don't count on them spilling the beans now, but watch how they dance around setting ANY specific limits.

The big picture

San Elijo has repeatedly proved their ability to change specifics within their Specific Plan. They are expert at hiding contradictory, double meaning, and open ended options within wording of their approvals. They always leave the door open for future change. With San Elijo, nothing is Specific and nothing presented to the public is certain. San Elijo's Specific Plan is simply the public shell of a much more impacting plan that is being introduced in smaller glimpses so as to cushion the ultimate shock by conditioning the public to accept repeated smaller shocks over time.

.The Unpalatable big picture won't be revealed for years yet. We have numerous step by step doses to swallow before then. Mark my words, we will receive notices of San Elijo proposed plan changes for the next 10 years. We need to keep tally. And we need ensure that San Marcos citizens and representatives are aware of that tally, lest the unaware public willingly consumes an entire bottle of arsenic, sip by sip, never recognizing the folly of their action.

The Escondido Creek Conservancy's (TECC) trash hotline has been ringing off the hook this month. One neighbor called in an illegal dumping (found in 3 large piles, "thoughtfully" spread over the entire length of a steep hill) on Canyon de Oro. TECC quickly made a trip to assess the situation and then followed up 2 days later by picking up all of the trash and taking it to the Resource Recovery Center. Once again Frank McCulloch joined the merry TECC'sters, lending his truck and strong arms to clean up the neighborhood. We filled one truck beyond its sides with discarded wood- some of it burned-, pipes, trellises, a large amount of metal debris, including auto parts, a tricycle, and the usual cans, bottles, and miscellaneous litter.

TECC hates to hear about illegal trash dumping in our beautiful valley, but we are proud that our trash hotline (760-471-9354) and able-bodied members are available to serve the community in such an important way.
