#### **Purchase Of Development Rights** By Joe Daubenmire / Thomas W. Blaine

What is PDR? - We may consider the ownership of land to be the possession of a "bundle of rights" associated with that land. These rights include the right to possess, use, modify, develop, lease, or sell the land. Mineral rights constitute one of the items in the bundle with which most people are aware. If the mineral rights have been separated from the remaining items in the bundle, the owner is prohibited from drilling for oil or from mining the land. The right to develop a piece of land for residential, commercial, or industrial purposes is also a right within the bundle. The purchase of development rights involves the sale of that right while leaving all the remaining rights as before.

PDR is a voluntary program, where a land trust (see OSU Extension Fact Sheet CDFS 1262-98, Land Trusts) or some other agency usually linked to local government, makes an offer to a landowner to buy the development rights on the parcel. The landowner is free to turn down the offer, or to try to negotiate a higher price. Once an agreement is made, a permanent deed restriction is placed on the property which restricts the type of activities that may take place on the land in perpetuity. In this way, a legally binding guarantee is achieved to ensure that the parcel will remain agricultural, or as open (green) space forever.

If the local agency in charge of operating the PDR program makes an offer reasonable to the landowner, then that landowner has the opportunity to realize the economic benefits accrued from the development potential of the land, while having the ability to keep the land as agricultural or open space. At any time after selling the development rights, the landowner may sell the property itself, lease it, or pass it on to heirs with the deed restriction attached. This is a significant change from the situation that farmers and landowners usually face as being "cash poor - land rich" and limited to the option of selling the land for development versus owning a very valuable piece of property while realizing none of the financial benefits. Why should a community consider farmland preservation programs? - If, as stated above, it is primarily market forces which are driving land out of agricultural and open space uses, then it is only natural to ask, why interfere with this process? If land achieves its "highest and best use" only when developed, should this not be allowed to happen? Why not allow the free market in real estate to determine land use?

I think the answer in our community is obvious. The provision of environmental and aesthetic amenities is typically not incorporated into the values of private markets. There is simply no way that most landowners can achieve financial rewards for providing these types of "public goods." Finally, some Americans are concerned that the nation's future capacity to produce its own food and fiber, and thus national security, will be compromised if the trends in loss of farmland and open space are not slowed down or stopped.

What are the advantages and disadvantages of PDR, as compared to other policy mechanisms to protect farmland, such as zoning, building moratoria, or tax breaks for agriculture? -Restrictions on land use, including zoning have been used to protect agriculture. One of the main benefits of PDR however, is that it is completely voluntary. Under PDR, the landowner is not deprived of any of the value of the property. This is very important because many farmers rely on their property in order to fund their retirement. Simply depriving them of the opportunity to realize the full economic value of their property has important ethical, socioeconomic, and perhaps legal ramifications. Moreover, zoning regulations may be easily changed in the future. Other regulatory mechanisms such as building moratoria have similar disadvantages to zoning.

PDR has several advantages over these other policies. First, since it is completely voluntary, no landowner is coerced into giving up or selling the land or the development rights. Second, it involves an (almost) permanent agreement that guarantees that the deed restriction will apply in perpetuity. Clauses for the extinguishment of the agreement typically involve requirements that the landowner demonstrate that surrounding development or economic conditions have made farming on the land impossible.

Another benefit of PDR is that it makes it much easier for one farmer to pass the farm on to an heir interested in continuing to farm. Once the development rights have been separated from the land, the value of the parcel typically declines to its agricultural value. This generally has an enormous effect on reducing the inheritance tax liability. If taxed at the full development value, many parcels are simply taxed out of agriculture, because the heirs are not able to pay the taxes without selling the land.

The primary disadvantage of PDR is the cost involved. In all of the states with PDR programs, these purchases are funded by some sort of tax.

#### How to Establish and Operate a PDR Program -

The establishment of a PDR program often begins at the local level, accompanied by enabling and/or funding legislation at the state level. The PDR programs which seem to have had the most success have been those where the objective has been to use this tool to create large contiguous areas with permanently preserved open space and farmland as opposed to selecting individual parcels piecemeal. #### Minutes Of Elfin Forest/Harmony Grove Town Council Meeting By Steve Barker

**Date:** March 1<sup>st</sup>, 2006

Call to Order: 7:30 PM.

**Members present:** Eric Anderson, Jacqueline Arsivaud-Benjamin, Steve Barker, Gordon Fines, Mid Hoppenrath, Betsy Keithley, Cheri Smith, Jeff Swenerton and Bill Wilgenburg

**Eric Anderson** opened the meeting and introduced **Russell Anderson** who read a poem about Elfin Forest.

Eric introduced BJ Williams, Captain Tom Bennett and Lieutenant Alex Dominguez from the San Marcos Substation of the County Sheriff's Department. BJ Williams, who coordinates The Neighborhood Watch program for our area, spoke on 2005 crime statistics. In 2005 we had eight thefts, seven burglaries, and two assaults. We have one of the lowest crime rates in the county. Captain Bennett talked about his new position as head of the San Marcos office and his background. He has 28 years in the department and most recently served in the homicide department. Lieutenant Dominguez heads up field operations for our area and has been in the position for about a year. The San Marcos substation is currently six deputies short of full staffing but Captain Bennett anticipates filling those vacancies prior to the end of the year.

Eric then introduced **Alex Newton** from the Olivenhain Municipal Water District and **Sherry Rogers** from the County Water Authority (CWA). Sherry is project manager for the Lake Hodges project that entails constructing a pipeline to connect the Olivenhain Reservoir with Lake Hodges. The project will allow CWA to maintain Lake Hodges at full capacity year round as well as produce power to sell back to SDGE. Alex said he would pass along the community's interest in a fishery in Olivenhain Reservoir to CWA management.

Eric introduced new board members Jeff Swenerton, Betsy Keithley, Jacqueline Arsivaud-Benjamin and Steve Barker. New officers are Eric Anderson, Chair; Cheri Smith, Vice Chair; Betsy Keithley, Treasurer; and Steve Barker, Secretary.

### What's Happening At The Fire Department – April 2006 By Captain Dawn Pettijohn



March training at the Questhaven retreat was a great success. Dispatched to a "Structure Fire," crews arrived to smoke billowing from the building and began their initial attack. The skills of interior

attack, search and rescue, ventilation and rapid intervention crews were completed as the scenario played out and embers from the structure fire ignited a vegetation fire on the hill below.



With Chief Twohy as the Incident Commander, a first alarm vegetation response was requested. Arriving brush engines began a progressive hose lay to catch the fire and provided structure protection to protect homes in the path of the fire.

The opportunity for our firefighters to practice their skills in this real life experience is invaluable. Luckily, the expected severe weather held until the

end, where we were blessed to experience the beautiful snow in this enchanting place. Many thanks to the warm and wonderful people at the Questhaven Retreat Christward Ministry for this training opportunity and the great lunch they provided after the drill.



Another grant has been submitted to the Starbucks California Giving Program. As a non-profit organization, the department requested \$23,000 for a washer extractor and dryer. This important health and safety equipment will provide our firefighters the ability to keep their personal protective clothing free of the toxic contaminants and carcinogens they are constantly exposed to at fires, vehicle accidents and medical aids without damage to the fire resistive properties of the material.

You will soon see a new addition to the front of the fire station. Our old wooden sign has served us well for many years, but the firefighters have long wanted something that would reflect the pride and professionalism we feel in serving our communities of Elfin Forest and Harmony Grove. This has been an ongoing project with Jennifer and Charles Coburn of Coburn Topiary, and we think the new sign will be a perfect fit for the ambiance of this special place. #### Garden Jobs for April By Evelyn Alemanni

A few weeks ago I was in Toronto participating in judge's training for the international Communities in Bloom. The surprise was the temperature there was the same as here! When I returned on March 12<sup>th</sup>, I was stunned to see the hail had turned my garden into a massive compost pile. What to do?

The short answer is... take your truck over to Elfin Valley Nursery and load up with new stuff. The longer answer is... wait and see. Give your plants three or four weeks to recover from the damage. While it's tempting to start pulling things out, drastically cutting back, and fertilizing, it's too soon. Also, in case there's more weird weather on the way, you need those remaining leaves and branches, even the damaged ones, to protect what's left.

Just as the first robin of spring has arrived, so have the baby bunnies. Oh my, they are so cute, and so hungry. They do as much damage as hail, or more. Check your community guide for a list of plants they don't like. The article is called "What did the bunny leave you?" If you don't have a community guide, now's the time to get one. The guide has valuable advice on overcoming the challenges of gardening in the rural environment. Besides lists of plants that bunnies won't eat, it has lists of deer resistant plants and plants that are poisonous to horses, dogs and cats. These lists can be a helpful guide as you consider what to plant this spring. If you don't already have a community guide, contact any town council board member or order one online at www.efhgtc.org.

We've been receiving tons of calls and emails from people asking about the garden festival. They are so disappointed that we aren't having it this year. Many said that they had enjoyed it so much in the past years and they wanted to bring their friends and relatives. Others have said they believe it to be the best garden
