Is our neighborhood safe? According to Officer B.J. Williams, Crime Prevention Specialist with our Sheriff's Department, the crime rate for the Elfin Forest/Harmony Grove neighborhood is very low. But are we really safe? This summer we have had several incidents that could cause concern including several fires of suspicious origin. Thanks to someone making a report and a rapid response from our fire department, all were extinguished in a timely manner. It is paramount that we all assess the fire danger to our homes, have evacuation plans, and provide appropriate areas free of combustible materials to ensure your safety and the safety of our firefighters in the event of a fire.

At the next Town Council Meeting on October 3

at the Fire House, Officer Williams will be discussing our police protection and a voluntary Neighborhood Watch Program. If your street or area is interested, this meeting will provide details on the program.

Last month we urged everyone to make sure all the residents on their street were signed up for Community Alerts, formally Elf Alerts. This communication has, over the years, informed us of everything from robberies and arson to lost pets and community forums. When something happens all the eyes of the community are at work immediately to apprehend the person and prevent further crime in the area.

As a result of last month's newsletter we had just a few people add their names. We know we are not reaching everyone.

We encourage people to check their area to ensure everyone is signed up. A special thanks to Karen Gardner for coordinating our Community Alerts. If you are not signed up, contact her at Karen@vintagematerialism.com.

Beautiful, Bountiful Bulbs

This summer I had the privilege of judging the international edition of the Communities in Bloom program. To choose an international winner, I traveled to England, Scotland, Ireland, and Canada to visit and evaluate towns that had won for their respective countries. The thread that ties all these winners together is their spectacular visual appeal, not just in their parks, but at their businesses, in residential gardens and public spaces. All of them said that looking good is what sets them apart from other towns and is an important part of their community character. Which brings me to my point. As a community, we can help preserve our rural character and define who we are through beautification, and what better way to do that than by planting seeds of native California poppies supplemented by bulbs that will naturalize and multiply. Developers are less likely to bulldoze a community that looks like it cares about itself.

Whether planting along the roadsides or in your own garden, the secret to

a fabulous springtime bulb display is to plant bulbs native to Mediterranean climates, which is what we enjoy here. Narcissus that bloom at various times can spread the bloom period over more than six weeks. They are poisonous to deer, rabbits, and squirrels, so there is little or no risk of them being dug up or eaten by wildlife. Planting time and schemes are important to success. But most important is to choose bulbs wisely. Just remember three little words: bigger is better! Why? Because bulbs store food for the plants and some actually contain the buds of flowers for the next season. Select bulbs that are firm to the touch.

Bulbs grow well in full or part sun, in well drained soil amended with organic compost. Plant bulbs at a depth of about two to three times their height. Plant them when the soil temperature drops to 50 degrees or less.

At planting time, some people like to add a scattering of bone meal and/or blood meal, or special bulb fertilizer. If dogs share your garden, re-

member that they will do whatever it takes to get to the bone meal and eat it so use a commercial 10-10-10 fertilizer instead. Fertilize again when you see the leaves emerge, but stop fertilizing once the bulbs have started to flower.

When planting bulbs, arrange them in groups rather than a single, straight row. In general, the broad part of the bulb goes down, tips go up. Water right after planting, and if rains don't come soon, be sure that the bulbs receive about one inch of water per week.

If you are making a mass planting (think hundreds or thousands of bulbs), just toss the bulbs on the ground, sprinkle some fertilizer, then cover with three inches of compost, and another 3 inches of mulch. Water well.

The meeting began at 7:35 pm at the Fire Station with the pledge of allegiance and introduction of members attending the meeting. There were good cookies available. Jeff Swenerton presented the format for the meeting. There is no invited speaker. There will be reports of committee activities and open forum.

Treasurer's Report - Betsy Keithley. There was no activity this month except that it now costs about \$430/month to produce the Chaparral because we are paying a professional printer. An accounting of the picnic is complete and we spent about \$600 more than we brought in.

Secretary's Report - Betsy Keithley. Although we have not had a General meeting in several months, the board has been meeting. Paul Malone, the City Manager of San Marcos met with us in June to talk about the current plans in San Marcos and their thinking on the University Heights Proposed housing develop-

ment.

Jeff Swenerton reported that DSL for internet communication is expected to be available in Elfin Forest early 2008. He also reported that the Escondido Creek Conservancy (TECC) fundraiser at Nancy Reed's house was a great success. The music was wonderful and the pit-roasted pig prepared by Tim Costanzo was delicious. Thanks to all who worked on and attended that event.

Jacqueline reported that the Bridges Developer is still pursuing the development of Unit 6. There will be no revised EIR. The Planning Commission is expected to hear the project in September or October. The application for Unit 7 development was withdrawn from the County Planning Dept, but the developer has not agreed to sell the property so that it can remain open space. Apparently the current homes in the earlier phases of the project are still selling very well.

The University Heights committee met and dis-

cussed strategies. If you are interested, please contact Melanie Fallon or Jeff Swenerton.

Mid Hoppenrath reported that she has no new information on HG Meadows and that there has not yet been a meeting with Escondido city representatives about the Citracado Extension across Harmony Grove Road to Del Dios highway.

Nona Barker presented an update on the Fire Department activities. They have 5 new firefighters whom Deputy Chief Don Heisser is training. Unfortunately, Bob Kephart retired from the Department. He took a job for OMWD and will remain on the Fire Board.

Fire Board elections are on October 8 when there will be the Annual Meeting. All residents/property owners in CSA 107 are urged to attend this important meeting concerning our fire protection and first response medical aid.

The County performed an audit of the finances

Jeff reported that B.J. Williams from the Sheriff's Department will be here at the next meeting in October to discuss setting up Neighborhood

Watch programs for interested residents.

Trails Committee Update



We are coordinating with the county to get the Kauana Loa multi-use pathway trail established. This trail will connect the north edge of Harmony Grove with southern Harmony Grove through the Village development, and further on, will connect to the Elfin Forest Recreational Reserve. The next step is to arrange

for a county survey of the road easement to allow trail building to begin. This trail will also connect to the Escondido Research and Technology Center and allow our residents to walk to the new Stone Brewing Company restaurant, and eventually, to the new hospital. We hope that it will encourage Village

residents who may work in the ERTC to bicycle there and leave their cars in the garage! We are coordinating with the planners for the Escondido Bicycle Master Trails Plan to help ensure that the county and city trails link together.

Update on University Heights

Since my last update on this 453 acre parcel north of the Questhaven Retreat we have had one Committee meeting, but as of this date, we still have no new information from the City of San Marcos, or the property owner/developer. At the Committee meeting we reaffirmed that any potential development of this property needs to meet the long held principles of the Elfin Forest/Harmony Grove communities, principles that are also contained in the County of San Diego's Draft Land Use Map – General Plan 2020. These principles include preserving our rural and


equestrian environment; protecting our diverse population of native plants and animals; and maintaining our many unique features – single family homes on large lots, equestrian ranches and trails, wildlife corridors and agricultural uses.

We also agreed that the City of San Marcos or the County of San Diego should not allow any development if it divides the Elfin Forest and Harmony Grove communities in half; if it allows any densities higher than proposed in the County's Draft General Plan 2020; if more traffic is dumped onto Elfin Forest Road;

if it removes any sensitive environmental habitat or if it visually impacts any Elfin Forest or Harmony Grove residence.

We will continue to monitor this proposed development and are looking forward to beginning a dialogue with the City of San Marcos and planning consultants as to the possible future use of this property. Please let me know if you have any questions or would like to join the University Heights Committee.

Bridges to pursue Unit 6 Development

The Bridges at Rancho Santa Fe are actively working on a revised application to develop "Unit 6", a 9 acre parcel formerly set aside as permanent biological easement as a condition of the original project development. The County staff reports that they expect the project to come in front of the Planning Commission in the next few months. Because this is a down-scaled version of their

previous application, the County does not plan to allow for a public comment period.

We have been circulating a petition to oppose development of Unit 6. Our main concern is that Unit 6 could be the precursor to Unit 7, which would bring sewer and its growth-inducing effects to Elfin Forest. Without Unit 6 there is no access to develop Unit 7. As of now Lennar has still not agreed to

sell the Unit 7 to a land conservancy, even though offers have been made at fair market value.

As of September 16th, a total of 65 community members, from Harmony Grove to Elfin Forest, have signed the petitions. These are being delivered to the County staff and to each of the supervisors.

Routers & Switches & Modems, Oh My!



Which Router?

Read reviews at the “Networking” category at <http://reviews.cnet.com/>

CNET’s testing lab gave the D-Link DIR-655 Xtreme N Gigabit router its highest speed rating in April 2007.

As we (hopefully) get closer to a wider roll out by AT&T of DSL broadband Internet service I thought it’d be timely to review the current options for sharing that connection in your home. As I’ve previously described, DSL (or Digital Subscriber Line) is a technology that uses your land line telephone’s copper wire pair to carry the Internet Service Provider’s (ISP) signal. A DSL modem connected to the copper pair is required and filters must be installed on your land line telephones to prevent interference. The DSL modem has a 10BaseT (10 megabit) Ethernet interface used to distribute the Internet connection. The maximum DSL download speed will be 1-6 megabits/sec based on your distance from the point of service (a DSLAM along Elfin Forest Road) and service plan.

A router is an intelligent device (it has its own little computer inside) used to share the connection from the DSL modem. Look for one with a

WAN or Wide Area Network port (to connect to the DSL modem), multiple RJ45 (type of connector) ports and support for 802.11 b/g/n wireless Ethernet. I’ll provide a web address for product reviews of specific models at the end of this article. The RJ45 ports allow you to connect multiple PCs (IBM compatible and/or Mac) and devices with wired Ethernet interfaces such as laser printers. 802.11 wireless allows you to connect laptop computers (again both IBM and Mac) and other wireless devices like the iPhone. The router lets all the wired and wireless devices simultaneously share the Internet connection and also gives them Ethernet access to each other.

In order for the devices connected to the router to harmoniously co-exist, the router performs the important function of assigning them Internet Protocol (IP) addresses (a number used as an identifying computer alias) through a software feature called Dynamic

Host Control Protocol server. The router can also provide some immunity from unwanted Internet intrusion with a software “firewall”.

802.11 b/g/n wireless offers 11, 54, and 248 megabits/sec theoretical maximum data rates, respectively. Unless you bought your laptop in the last month, it will have either 802.11b or g networking. The wireless n standard is still evolving. As the maximum DSL speed is far below the 802.11b standard, g or n networking only improves the transfer speed between devices on your network. Also, wireless speeds and the ability to establish a connection at all significantly diminishes with distance from the router.

Finally, if the number of wired devices you want to connect exceeds the four RJ45 ports typically found on a router then you need another intelligent device called a network switch. Switches usually have from four to thirty-two RJ45 ports. An Ethernet patch cable connects the router to the

switch. My home network includes a Linksys WRT350N router and twenty-four port Netgear JGS524 switch both of which support 1000BaseT (gigabit Ethernet).

its highest speed rating in April 2007. But distance (or expense) rather than speed may be your criteria for purchase so shop around.

Ham Radio

Ham Radio is an alternative way to communicate with others in the San Diego County as well as around the world. In order to operate a ham radio, you must be licensed by the FCC. In order to be licensed, you must pass a written exam. There are 3 license levels: 1. Technician, 2. General, and 3. Extra. In an emergency, regular phones and cell phones may be jammed or may be shut down, as was in the case of the Harmony Grove fire of 97. Ham radio operators can use “Repeaters”, which are very large antennas on large structures. Occasionally, these repeaters will not work if there is no electricity or if their batteries are out. In this case, ham radios can still oper-

ate by “ground wave propagation”, or by sending the radio waves over the ground. I have actually tried to see how far I could communicate via ground wave propagation, and so far I have been able to talk as far as Balboa Ave and Mercury Street in San Diego. For those people who are CERT trained, ham radio licenses are an additional help.

In February of 2006, I studied for and passed the Technician level ham radio exam. I had no understanding of electricity, radios, repeaters, etc, yet I still passed. This year I passed the General exam. That allows me to operate a radio worldwide. Since I could not hook up a stereo system, when I tell you that if I can pass this

exam, anyone can, please believe me. It takes some study and memorization. I have web links that can be accessed to study for this exam. I can also find out if there are local classes that can prepare you for you license exam. These classes are usually sponsored by the Palomar Amateur Radio Club or Escondido Amateur Radio Club. If you are interested in finding out more about becoming a licensed ham radio operator, please call or e-mail me. Named **'Onyx Ridge'**, this property includes 'backyard open space' for nine future house lots, plus a 50-acre undeveloped parcel. 

Fall into Free Waterwise Landscaping

The Olivenhain Municipal Water District, the Santa Fe Irrigation District and San Dieguito Water District are holding free landscaping workshops for residents in the three agencies' service areas. Beginning October 18, 2007 a workshop will be held every Thursday through November 8, 2007. Workshops will take place 9:00 am to 12:00 pm at the Rancho Santa Fe Garden Club (last workshop will be held 8:30 am to 11:30 pm). The workshops are designed to promote good water management practices while still enjoying a lush, colorful landscape.

When it comes to planting, many homeowners think only of spring;

however in much of the country, fall is the ideal time to plant cool-season veggies, turf grasses, perennials, trees and shrubs. Fall officially begins with the autumnal equinox in late September, and for most folks September and October is an ideal time for fall planting.

Why is fall planting good for plants? In the fall, the warm soil encourages root growth. Roots continue to grow through the winter. In early spring, roots begin new growth or continue to develop at a faster rate, and top growth begins. While the same plant planted in spring gets a slow start due to cool soils, those planted in fall are becoming well established. When sum-

mer finally arrives, the fall-planted specimen is far better equipped to deal with heat and drought, largely due to its well-established root system.

Of course, there are plenty of other good reasons to plant in the fall such as rainfall, cooler weather and fewer pest and disease problems. In addition, many plants are on sale at nurseries, which makes fall planting nice for your wallet too!

There is an increasing need for water conservation in San Diego due to the dry weather conditions, environmental concerns, and the low levels of snow pack, rainfall, and the Colorado River. Water agencies now focus on ways to save water outdoors as irrigation accounts for

60% of urban water use. With increased awareness of water-efficient landscape techniques, communities can also be proactive in avoiding stagnant water, insect problems, unstable soil conditions and other saturation issues that occur with over-watering. Irrigation run-off can also contribute to storm water pollution, carrying pesticides, bacteria and litter to our waterways and beaches.

Currently, the District includes over 48 square miles, and serves a population of approximately 58,000 residents. The District includes portions of the cities of Encinitas, Carlsbad, and Solana Beach as well as the communities of Olivenhain, Leucadia, Elfin Forest, Rancho Santa Fe, Fairbanks Ranch, Santa Fe Valley and 4S Ranch. Biking Across America

How did you spend your summer vacation? If you're like many of our energetic neighbors maybe you remodeled, landscaped or painted. Most likely you didn't bike 3800 miles across the United States unless you're Marv Steinman, one of our very own local residents. Marv joined up with America by Bicycle, a bicycle tour group, and pedaled from Oregon to New Hampshire on a recumbent bike for 50 days this past summer. The ride was completed in its entirety along with approximately 60 other members who trained religiously starting in January in order to be prepared for their trek across the states.

Marv's training included rides up to 115 miles a day out to Palomar Mountain, Cabrillo National Monument and the North county inland area. Of the 60 or so riders who made the entire trip, Marv was the sole rider on an recumbent bike (the bike has one 20 inch front wheel, a standard size rear wheel and a wider seat which eliminates saddle sores). The disadvantage of the

recumbent bike is when climbing steep hills like when Marv climbed Teton pass which included a 10 mile continuous very steep climb in the heat of the day.

America by Bicycle's Cross Country Tour offers shorter rides as well as the Across America North tour which covered 11 states including Oregon, Idaho, Wyoming, South Dakota, Minnesota, Wisconsin, Michigan, Ontario Canada, New York, Vermont and New Hampshire.

The tour's service included accommodations, meals, support and gear vans, and training instruction. Fortunately for Marv, not much gear support was needed with only two flat tires and not one drop of rain (yes, you read that right). The average number of flats on such a trip is 4 or 5 so he fared well (unlike another group on a 3 seater who had the most with 15). Some of Marv's most memorable moments were the views of the Teton Mountain range and Niagara Falls.

So what do you do after 3800 miles, 79 road kill sightings, 150 bananas,



75 packs of fig newtons and 1 sore gluteus maximus? Go back to remodeling, landscaping and painting, what else?


